



Triple Threat Dance Convention Information

Warmland Dance will be participating in Triple Threat Dance Convention held on Saturday and Sunday November 26 & 27 at the Westin Bayshore Hotel in Vancouver.

We will travel with parent chaperones by BC Ferries on **Friday November 25** from Nanaimo, and will stay until the end of the convention on **Sunday the 27**, returning the same evening, ferry times TBD.

There will be one adult chaperone per hotel room, with 3 dancers per room. We will remain at the hotel and will not be traveling by car to other destinations in the city. We may travel on foot to nearby restaurant/coffee shops for dinners/breaks, and students will remain with chaperones at all times.

Warmland students will receive the special studio rate for the convention, and we receive a reduced hotel rate at the Westin Bayshore as well.

Please pack snacks, a bagged lunch, and water for in between classes. Please bring a refillable water bottle to use at the provided water stations. Most venues choose to set up a concession stand with sandwiches, etc. available for purchase during the breaks & lunchtime. Please send cash with your child for additional food/snacks and any convention merchandise they may wish to purchase. Dinner on Friday, Saturday and Sunday, included in the cost, will either be room service, pizza, or at a nearby restaurant.

Students should wear proper dance attire/hair for a contemporary class, and bring all styles of dance shoes.

Parents/family members are welcome to attend as observers, and must purchase an observer pass for the event. If you plan to attend with your child in your own vehicle, purchase dinner separately, and stay in your own room, you may register for convention ticket only.
