- Whilst any member is riding all dogs are to be on a leash and bicycles can only be ridden with extreme care, particularly around the feed-yards.
- Junior riders must be accompanied at all times when riding (either with other riders, or by their parent, or another adult). Close supervision is needed for riders with limited riding experience.
- Children under 16yrs are not permitted on the grounds without an adult at any time (regardless of the time or the activity being undertaken).
- Driving speed at our grounds is to be kept to a maximum of 20km's, except around the feed-yards when speed is to be at walking pace. Horses and young children can be unpredictable and extreme care is to be taken at all times. Horses have right of way at all times.
- A letter box has been installed at the main entry gate into the show jumping arena for Horse Health Declarations. A HHD must be completed and placed in the letterbox for all visiting (non-agisting) member horses.
- Access to our grounds is shared by club members, NCEC employees and candidates, event participants and users as well as industry service providers, visiting instructors and members of the public. Pedestrians and horses have right of way at the grounds at all times.
- Washing of horse floats at our grounds is prohibited, except in exceptional circumstances. Our water bill is a major cost to the club and water is to be used for watering and washing horses only. Any water leaks should be reported urgently to a committee member.
- > To book the main arena lights please contact Gael Gant for a key and ensure you email Justin so appropriate charges can be made to your member account.
- PCAQ provides insurance coverage for riders at approved official and unofficial events (across all Pony Club disciplines) and at musters and club days. HPC holds secondary public liability insurance for members riding at our grounds at all other times.
- Instructors must be, as a minimum, NCAS Prelim or EA qualified. The minimum age for NCAS Prelim qualification is 18yrs and certification can only be achieved after 2-3years of study and assisting at musters. Only PCAQ and EA qualified Instructors {with appropriate professional indemnity insurance} are permitted to provide lessons at our grounds.
- New members have 3 months to obtain muster and formal uniforms (muster points will not be deducted during that time), however riders must present neatly in a collared shirt and jodhpurs or breeches. A muster fee of \$5.00 is charged for all musters and is to be paid on the day.
- The Hendra Pony Club is a smoke free sporting club and smoking is prohibited at our grounds at all times, other than as designated during events (ie; at individual floats).
- > Horses are not permitted in the club house yard except under strict control (ie; in hand or tied up).
- Gates must be secured at all times. This includes the main gates (to Nudgee Road) which must be locked when no one is onsite. If in doubt gates should be locked. Gates to all enclosures must be secured to ensure horses do not enter to graze (or without a rider).
- The Nundah Community Coop (NCEC) have a sublease at our grounds and they also facilitate the Skilling Queenslanders for Work program (Re-gen). Information about, or concerns with, NCEC or the Re-gen project can be directed to a Committee member at any time.
