## Website:

## Bands:

Chuck reports revenue for bands based on Band Year. Chuck Romano sent a band report prior to the meeting to all Board members. Revenue from band sales was similar to this time last year.

## Affiliations:

Affiliation and patronage forms will be separated. A motion that the patronage form for a show must be turned in 2 months prior to the show for points to count, effective immediately, passed.

Ranking: Henry reported that he doesn't track wins, but relies on exhibitors to notify him when they are eligible to advance.

## Membership:

Virgil Oliphant reported that we have 144 members. Efforts will be made by member volunteers to contact members who have not renewed.

## Ranking and Advancement:

The board voted that starting in year 2014 there will be no combined award.

## Registration:

Ken Saxion reported there have been only 4 aviaries that have registered and 4 birds.

Patronage: Maureen Broderick has been sending out medallions and CCs by the first of April.

## NEW BUSINESS:

- A motion that the term duration for the office of chairman be three years passed.
- Stuart Sacks will keep all data pertinent to BAA as backup.
- A motion passed stating that for CCs to count in the Rare division there must be at least two birds. Additionally, if a bird should place in the top 10 of either the Rare Division or on the top bench it will qualify for a CC..
- A committee consisting of Maureen Broderick, Virgil Oliphant, and Julie Willis, committee chair, will review the way points are calculated.
- The 2014 Grand National will be put on by BAC in CA.
