- C. Mayor Curry appointed Kevin Cox to serve on the Horse Cave Code Enforcement Board. Motion made by Vickie Rogers, seconded by Perry Martin to confirm the appointment. Motion carried 5-0.

D. Mayor Curry requested that one of the Dodge police cruisers, which has engine problems be transferred for use by Donnie Parker, Fire Chief.
