"Forum: Financial regulation and civil liability" – Launch of the book "Financial Regulation and Civil Liability in European Law" (EE 2020)

- About the speakers -

- 1. Professor Guido Alpa has taught Civil Law, Comparative Private Law and Comparative Legal Systems at Genoa University and was until recently Full Professor at the Faculty of Law at La Sapienza University in Rome and director of the Master's course in European Private Law since 2004. Having held the role of Chairman of the National Bar Association of Italy for many years since 1995, Professor Alpa is also a Visiting Professor at a number of Universities including Oregon University and Berkeley in California, the University of London and the University of Oxford and has also taught at the Malta University Summer School and the Summer Schools of London's Institute of Advanced Legal Studies and King's College.
- 2. Professor Mads Andenas, QC holds a Chair in the Faculty of Law, the University of Oslo, Norway. He is a director of the London Centre for Commercial and Financial Law and remains a Visiting Research Fellow of the Institute of European and Comparative Law, University of Oxford and a Senior Research Fellow a Institute of Advanced Legal Studies, School of Advanced Studies, University of London. He has held senior academic appointments in the United Kingdom, including as Director of the British Institute of International and Comparative Law, London and Director of the Centre of European Law at King's College, University of London.
- **3. Professor Olha O. Cherednychenko** holds a Chair in European Private Law and Comparative Law at the University of Groningen. She is also the Founding Director of the Groningen Centre for European Financial Services Law (GCEFSL). She has published extensively in the fields of European private law, comparative law, and financial law, exploring a wide range of issues at the cross-section of EU and national law as well as public and private law. In particular, her research focuses on the interplay between market regulation and private law. She has recently edited the book 'Financial Regulation and Civil Liability in European Law', Edward Elgar 2020 (together with Mads Andenas).
- 4. Professor Jan H Dalhuisen is Professor Emeritus at Kings College London and Chair in Transnational Financial Law at the Catholic University in Lisbon. He is the author of the seminal Hart title: "Dalhuisen on Transnational and Comparative Commercial, Financial and Trade Law" in three volumes. Prof. Dalhuisen is also Visiting Professor at the University of California Berkeley and former Visiting Professor at the Tsinghua University in Beijing, the University of Hong Kong, the University of Singapore (NUS), Tel Aviv University, the University of New South Wales in Sydney, Australia, and the University of Utrecht in The Netherlands.

- **5. Dr. Federico Della Negra** is a Legal Counsel at the European Central Bank and obtained his PhD in law at the European University Institute in Florence, Italy. His thesis has been published as "MiFID II and Private Law: Enforcing EU Conduct of Business Rules" with Hart Publishing.
- 6. Dr. Maren Heidemann is a director of the London Centre of Commercial and Financial Law. Alongside legal practice work in Germany, Austria and the UK, Dr Heidemann has held a number of full time and visiting lectureships in the UK since 2007 including at the University of Westminster and University of Glasgow. Dr Heidemann has been working for the University of London since 2010 in various roles including as research fellow at the Institute of Advanced Legal Studies (IALS), School of Advanced Studies, University of London and as Teaching Fellow and tutor at the Centre for Commercial Law Studies (CCLS) at Queen Mary, University of London. She is the author of M Heidemann, Transnational Commercial Law (Palgrave MacMillan, London 2018).
- 7. Professor Ettore Maria Lombardi is Professor of Private Law and International Business Law, and Director of the "Mediation Advanced Course" at the University of Florence School of Law. He holds a J.D. (University of Florence), a J.C.L. (Pontifical University of Lateran), an LL.M. (Harvard Law School), and a Ph.D. (University of Florence). Prof. Lombardi has been teaching and researching in the most prestigious American, British and German universities. He is a lawyer in Italy and a member of various international legal associations. He has also recently been appointed a Director of the "Alternative Investments Executive Course" coorganized by the University of Florence School of Law and the Queen Mary University of London (Centre for Commercial Law Studies CCLS), co-leading with Professor Rodrigo Olivares-Caminal of QMUL.
- 8. Dr. Antonio Marcacci is a Compliance Senior Associate at a European, global systemically important, bank. He obtained an LL.M. and a Ph.D. in Law at the European University Institute (EUI) in Florence. Alongside his work at the bank, he teaches EU and US Banking and Financial Law at the University of Passau and the University of Leipzig. He has published a book on investor protection law (Palgrave 2018) as well as several articles and book chapters on this topic.
- **9.** Yane Svetiev is Associate Professor of Contract Law at the University of Sydney and Associate Professor of EU Law at Bocconi University in Milan. His book 'Experimentalist Competition Law and the Regulation of Markets' is to be published by Hart in 2020.
- **10. Professor Takis Tridimas** holds a Chair in European Law at the Dickson Poon School of Law, King's College London, and is the Director of the Centre of European Law. He is also the Nancy A. Patterson Distinguished Faculty Scholar, Professor at Pennsylvania State University, and a Barrister in Matrix Chambers. He has published widely in the field of EU law.
- **11. Dr. Marnix W. Wallinga** is an Attorney at Stibbe in Amsterdam, specializing in litigation and dispute resolution. He is also a Research Fellow at the Groningen Centre for European Financial Services Law (GCEFSL), University of Groningen. He holds a Ph.D. in Law from this university. He has published on EU regulation, private law, and consumer law in the area of financial services. His monograph on EU investor protection regulation and liability for investment losses is forthcoming with Springer.
