

## **January 20, 2015 City Council Minutes**

This regular meeting of the Connellsville City Council was held this evening at 6:00 PM at City Hall, Connellsville, PA. Attending this meeting was Mayor Lincoln, Council members Geyer, Zolbrod, Karpiak and Ritch. Also attending this meeting was City Clerk and Solicitor Witt. •

• Reminder of the procedures for public participation during City Council meetings. Mayor Lincoln gave speakers Five Minutes each. •

### **•REMARKS FROM VISITORS/PUBLIC COMMENTS:•**

• Bob Topper, New Haven Hose Co., Report from NHH Co., Seventeen volunteers have completed State Certified Hazardous Training, ISO inspection tomorrow (current rating 5) – Topper noted with the paid Fire Department gone that will affect the City's ISO Rating. He further noted he hopes to counter that with the number of volunteers, equipment training and documentation they have. New Haven needs \$40,000 per year for new truck from the City. •

Ritch thanked Bob Topper and New Haven Hose volunteers, noting he realizes they do more than just fires. •

Linda Shearer, Support Our Police items will be for sale. •

Tom Currey, Board of Health's 2014 review of activity. He noted there are grants and help available for those with low income to help them address their property issues. Currey noted we demolished eight properties in 2014. He added since the Property Maintenance Ordinances was changed, the City has been saving \$6.49 per Certified Mailing since he can now post on a property. •

Johana Harden, Garden Club, Discussed Cameron Court's Park proposal (landscape architect Skip Colburn) cost of \$453,000. She noted many projects they have completed. •

Skip Colborn, assisting the Garden Club with the Cameron Court Project which is located at Pittsburgh Street and Fairview Avenue, presented the upcoming project. •

Dave Dunn and Kathleen Pysh, Columbia Gas, Right of way for pipe behind Martin's Plaza •

Lucille King, Trail Book, Snow shoveling (volunteers and those in need), illegal parking •

Mayor Lincoln responded to Mrs. King's comments. He stated they are enforcing the parking in the downtown area. He further noted he was not aware of parking problems on the west side. He then discussed parking issues in different areas. •

Police Chief Capitos responded to parking on East Crawford Avenue. •
