Innes read the Treasurer's report into record as of July 31, 2020. General Fund account balance \$1,473.72, Investment account balance \$112,970.08, Tax Checking account balance \$167,483.22, Tax Savings account balance \$23,389.28. The balance difference in the General fund and Investment account from September 30, 2019 to September 30, 2020 is +\$1,524.51. Motion by McCarty to accept the Treasurer's report as presented, supported by Kelly. All Ayes

<u>Assessor's Report</u>: Lupo is still working on the new database and hearing more on the designated assessor, which each township will be billed for, whether used or not. Nathan Hagar proposed a \$5000 retainer and \$25 per parcel, while John Barsou proposed a \$2500 retainer and \$10 per parcel.

<u>County Commissioner's Report:</u> Commissioners are working to finalize the 2021 county budget. The Building & Grounds Supervisor position has been advertised for starting wage between \$18.95-\$23.66 per hour plus benefits. Revenues at the County Parks increased, even while missing the first month of camping due to Covid-19.

Z.A. Report: Land split on Church & Maple Grove, also a land split for Steve Klaus. Two other land splits coming on Snover Rd. for Brown, but they're undecided on a couple things yet.

<u>Public Comment:</u> Roger Knight said he sees stakes by the bridge west of his home, inquired if it's going to be replaced? Sonck stated the board would be voting on it tonight.

<u>Communications Received:</u> Innes received a request from the Warren Group for a copy of the entire tax roll. We can charge them \$0.25 per parcel for the information.

McCarty stated there's currently 8,500 AV ballots out in the county, she's issued 132 in the township and 47 have been returned. Also, Lawyer's Committee for Civil Rights Under the Law have applied to have Election Challengers in our county precincts.

Sonck had a conference call with Waste Management, DEQ, and the Health Dept. regarding the new PFAS levels. They're concentrating on the properties along Church Rd that adjoin the dump. There was one request for testing from a resident on M-46 and they are waiting for approval to have that done. There aren't any changes to the levels that they've been monitoring for the last 15 years.
