

## Central West 4wd Park (CW4wdP) Rules & Regulations

1. Enter CW4wdP at your own risk. The property consists of unimproved bushland and mountainous terrain.
2. A waiver must be signed before entering CW4wdP by each visitor and on behalf of each child under 18 years of age.
3. All vehicles must be road registered unless approved by CW4wdP. No motorbikes, quads or ATV's are permitted due to council restrictions. Drivers must hold a valid drivers license.
4. No single vehicles are permitted. No less than 2 cars per group booking with minimum 2 night stay.
5. Only 4wd vehicles are permitted unless approved by CW4wdP.
6. Drivers must know how to select 4wd and know how to operate their vehicle.
7. No night driving allowed on the property unless approved by CW4wdP owner.
8. It is advisable that drivers complete a 4wd training course before entering the park.
9. Do not drive tracks if you do not feel comfortable or are concerned about causing damage to the property or your vehicle.
10. CW4wdP or the property owners will not be held responsible for any damage to vehicles or property.
11. All vehicles must be in 4wd drive anywhere around the park to save the tracks and minimize road deterioration and excessive dust.
12. Park vehicles safely and walk tracks to ensure that you feel comfortable to drive, if in doubt.
13. Front and rear recovery points must be on vehicles.
14. Park visitors must be able to self-recover vehicle as the owners of the property do not provide recovery assistance.
15. Speed limit on designated tracks and roads around the park is 10 kilometres an hour.
16. Speed limit around camp grounds is 5 kilometres an hour.
17. Be aware around reversing vehicles. If you cannot see behind you, seek assistance or guidance.
18. Children must be supervised at all times.
19. There are many old gold mines around the property. Visitors must be vigilant and aware when walking and driving around property.
20. No entering of gold mines or gold prospecting.
21. CW4wdP is an alcohol free zone for drivers, navigators and spectators.
22. Illegal including narcotic drugs are not permitted.
23. Visitors must stay on designated roads and tracks.
24. Do not make new tracks or deviate off existing tracks.
25. All rubbish is to be taken from the property and disposed of responsibly.
26. No pets allowed on the property unless approved by property owners. Permission will not be granted for pets on a long weekend.
27. Showers are restricted to 3 minutes as CW4wdP relies on tank water.
28. No firewood or livestock is to be taken from the property.
29. No chainsaws are allowed on the property.
30. Firewood can be picked up from the ground to be used in camp fires on property only.
31. Total fire bans are to be strictly adhered to at all times.
32. When permitted camp fires in fire pits provided only.
33. Visitors may bring their own fire pit but it must not damage the campgrounds, ash can be placed into existing fire pits.
34. No glass, cans or anything non-combustible to be put in fires.

35. All vehicles must carry 20 litres of water for fire fighting purposes.
36. No firearms, fire works or crossbows allowed on property.
37. If you need urgent attention, then please phone 0408 611 700 or contact UHF channel 16.
38. All vehicles need to have suitable electronic communication systems in case of emergency.
39. Bad behaviour including offensive language will not be tolerated and you will be asked to leave.
40. CW4wdP will be closed in extreme weather especially constant rain.
41. CW4wdP will be opened by group bookings only and may close for private bookings at our discretion.
42. Seat belts must be worn and vehicles must not carry more passengers than seat belts in the vehicle. Children must be restrained in seat belts at all times and must not be carried on laps.
43. All passengers are to be seated in vehicle, no standing on trays or any other part of vehicle.
44. Vehicles need to be in good operational order ie; good brakes and no leaking fluids.
45. If rocks are used to stabilise caravans in campgrounds the rocks are to be replaced back to existing location, for ease of future mowing.
46. If camping along river campground, proper bush toilet procedures need to be used ie: no closer than 100m off river, taking toilet paper with you, etc.
