The Lessons in Leadership Competitive Event is a State Event with parts conducted prior to <u>and</u> in-person at the NJ FCCLA Fall Leadership Connection. It is an *individual* or *team* event that allows members to demonstrate their knowledge of FCCLA. This event has four (4) parts: an oral presentation (submitted prior to FLC), leadership quotes (submitted prior to FLC), a question-and-answer form (submitted prior to FLC), and a multiple-choice test (in-person at FLC).

ELIGIBILITY

- 1. Participation is open to any affiliated FCCLA member. Affiliation for each participant must be submitted by **November 1, 2022**.
- 2. A chapter may submit two (2) entry in each event category.
- 3. An entry is defined as one (1) individual participant or one (1) team of no more than three (3) participants.
- 4. A member may only participate in this event once; either as a junior member or senior/occupational member.
- 5. An event category is determined by the participant's grade in school.

REGULATIONS

- 1. Participant(s) must be registered and attend the current year's NJ FCCLA Fall Leadership Connection to participate in this event.
- 2. Each entry will have an assigned digital folder to submit their project materials via Google Drive. A link to submit materials will be provided to the adviser upon competitive event registration. All entries must be submitted by **November 9, 2022,** and privacy settings must be viewable to anyone with the link.
- 3. The following materials must be included and labeled in the assigned digital folder and submitted by **November 9, 2022:**
 - Project Identification Sheet
 - Oral Presentation recording
 - Leadership Quotes
 - Question and Answer Form
 - Academic Integrity Form
- 4. Each participant must supply a **Project Identification Sheet** with the following information:
 - A. Participant's Name
 - B. School Name
 - C. Chapter Name
 - D. Event Name (Lessons in Leadership)
 - E. Event Category
- 5. The first part of this event includes reciting the FCCLA Creed. The oral presentation section of this event will be prerecorded. This oral presentation section of Lessons in Leadership encourages creative and "dramatic" presentations of the FCCLA creed. The recitation section <u>may be up to</u> two (2) minutes long and will be prerecorded and submitted in the electronic project folder. Failure to submit the oral presentation in the folder will result in loss of points.
- 6. In the second part of this event is participants are expected to research leadership quotes and select three (3) that relate to the FCCLA Mission and Purposes. Participants must explain the relationship.

7. The third part is the completion of the answer the question form. These questions discuss student participation in FCCLA and how it relates to leadership. This form can be up to 2 pages.

- 8. The final part of this event will be in person at the FLC prior to the opening session. Each individual/team will complete an objective examination about the history, mission, purposes, and programs of the organization. The test will include, but is not limited to, information found on the New Jersey FCCLA website at https://www.njfccla.org/, the National FCCLA website at <a href="https
- 9. Each participant will complete the twenty-five (25) question examination, in person at the NJ FCCLA Fall Leadership Connection. Participants will NOT be allowed to bring in pre-written notes or reference materials to the test site.
- 10. Participants are expected to cooperate and follow the instructions of the room facilitator prior to and during the testing situation. Tests will be given to each individual. Tests may be given either electronically or traditionally with paper and pencil. Scores will be averaged for each team. Prior to taking the test, participants must sign an Academic Integrity Form stating that they will in no way attempt to cheat during the test. Any suggestion of cheating will result in disqualification.

LESSONS IN LEADERSHIP SPECIFICATIONS

Knowledge of FCCLA

Each participant will be given 30 minutes to complete an objective examination. The event will take place at the Fall Leadership Conference. Participants will not be allowed to refer to pre-written notes or reference materials during the test. Business attire or competition attire is required for the test.

Knowledge Test	A 25-question knowledge test will be administered at the FLC. It will be a timed test. An academic integrity form must be signed and submitted before the test.
Academic Integrity Form	The Academic Integrity Form is attached below and must be signed and submitted into the digital folder before the test is administered.

Oral Presentation

The oral presentation may be up to two (2) minutes long and is prerecorded and submitted prior to the Fall Leadership Conference. The presentation should be a creative and dramatic presentation of the FCCLA creed.
