

NDEPENDENCE DAY - August 6 - has always been the most significant date on the national calendar in Jamaica and for Jamaicans residing overseas. Each year, we look forward to our vibrant celebrations, including national festival and gospel song competitions, Festival Queen and Farm Queen pageants, fireworks and the much-anticipated Grand Gala at the National Stadium. It is a time to celebrate and showcase the best from our deep reservoir of talents in every domain, while inspiring hope and unity.

> To alleviate the negative impacts of our borders being closed and the economic slowdown, the Government provided stimulus packages, including to the unemployed and pensioners. My sincere appreciation to Jamaican diaspora members for their tremendous help, tangible and intangible, to fellow Jamaicans, especially those stranded in the United States after Jamaica's borders closed in March.

Let me also extend condolences to those grieving the loss of loved ones to COVID-19, and pray for speedy recovery for those still struggling.

Nonetheless, resilient and strong: let's celebrate Jamaica 58, as a people of steely resolve and tenacious Jamaican spirit. Despite these monumental challenges, I firmly believe we have a bright future ahead. Let us all join hands and hearts to make Jamaica a better place.

A Jamaica College alum, he serves on the Diversity Committee for Broward County School Board.




Marcia Harris

When should I report a death to the... ADMINISTRATOR-GENERAL'S DEPARTMENT

You <u>MUST</u> report the death of a person to our office where these three circumstances exist:

- The deceased did not leave a Will (that is, died intestate);
- The deceased left children under the age of 18 years; and
- There are assets in the estate such as property, bank accounts, insurance policies, shares, motor vehicle, NHT Contribution Refund

In order to process the report of a death, we will require the following from you:

- 1. A properly completed Form of Particulars (FP) witnessed by a Justice of the Peace or Notary Public. (The FP is available at our offices and on our website at www.agd.gov.jm)
- 2. Original Death Certificate
- **3.** Proof that you are related to the deceased for example Birth Certificate, Marriage Certificate
- 4. Proof of assets belonging to the deceased including bank passbooks, land ownership documents (eg. duplicate Certificates of Title and Common Law Conveyance), share certificates, motor vehicle documents, insurance policies, certificates of deposit
- 5. Funds towards administration expenses, if no cash is left by the deceased

An Instrument of Administration will be issued by the Agency within three (3) months of all the required documents being submitted. This Instrument allows the Administrator-General to administer the estate.



At one and a half minutes to midnight, the first verse of the British anthem was played. The lights on the 60-foot pylons were put out and darkness descended upon the arena.

In the hush that followed, the Union Jack, which waved over Jamaica for 307 years, was hauled down. Then, 30 seconds to midnight, the lights came on again and the Jamaican flag was raised to the top of the flagpole. Then, both verses of the national anthem were played.

At the ceremony were the governor, Sir Kenneth Blackburne, Jamaica's first governor general, his wife, Lady Blackburne, and Jamaica's premier, Sir Alexander Bustamante, who was later sworn in as prime minister.

Also present were Princess Margaret. who was representing the Queen, and her husband, the Earl of Snowdon. There were also dignitaries from many countries such as the United States. Australia, Pakistan and the United Kingdom

FIRST GOVERNMENT

The Jamaica Labour Party formed the first government of independent Jamaica, having beaten the People's National Party by polling 72.88 per cent of the voters in the election that was held on April 10, 1962. This was after the Jamaican people voted against joining the West Indies Federation in 1961.



The parade was led by Miss City of Kingston, Mitsy Constantine. Effigies of Louise Bennett, Ranny

Williams, and Alexander Bustamante were also present.

In addition, The Gleaner Company and N.V. Phillips of London made ten 23-inch television sets available for the viewing of the celebration at Victoria Park, Kingston.

Leading up to the celebrations, certain key things had to be finalised. The design of the flag was chosen through a collaborative effort by government officials. The motto, 'Out of many, one people', was chosen by Legislature in 1962. The national anthem was written by Reverend Hugh Sherlock, while the music was provided by Robert Lightbourne. The national symbols were chosen by a select committee in the Jamaica Horticultural Society.

Since that time, a few things have changed. After the flag-raising ceremony in 1962, there was a much smaller celebration for the anniversary of Independence in 1963.

But in 1964, a structured Jamaica Festival began, where there was a parade as well as a showcase of arts.

In 1997, when Emancipation Day was introduced as a national holiday on August 1, celebrations started from July 31 and ended on Independence Day, August 6. As time progressed, Jamaica Festival was separated from the Jamaica Festival of the Arts.



Hon Yvette D. Clarke US CONGRESS

THE HON Yvette D. Clarke returns to the US Congress for another term, defeating four opponents in the June 23, Democratic Primary for the 9th District seat in Brooklyn, NY. She is the daughter of Jamaican immigrants, including mother Dr. Una S.T. Clarke, a champion of NY City politics.
