

DISTINGUISHED ALUMNUS HONORABLE MILTON RAYMOND SILVA, 96, OBITUARY



Honorable Milton Raymond Silva, 96, retired presiding justice of the Second District Court of Bristol County for twenty years, passed away peacefully at his home on February 14th, reuniting with his "valentine", the late Mary C. (Gaspar) Silva, with whom he shared 63 years of marriage. Born in Fall River, he was the son of the late Anthony T. and Mary L. (Benevides) Silva; father of Paul F. Silva (wife-Filomena) of Fall River, Tina LaFranchi (husband-Larry) of Richmond, MA, Richard H. Silva of Somerset, Martin A. Silva (wife-Kathi) of Somerset and the late Ana Larrivee (husband-Gary of Westport); brother of Madeline Murphy (husband-the late Leo, Jr.) beloved "Papa" of Brian LaFranchi (wife-Hillary), Amy Rigtrup (husband-Jonathan), Alan LaFranchi, Melanie Silva (husband-Alex Correia), Michael Silva (companion-Pernilla Kaiser), Richard LaFranchi (wife-Amorette), Patricia Robinson (husband-Patrick), Jessica Silva, Maxwell Silva (partner-Matthew Basta), Elliot Silva & Robert Larrivee; GREAT "Papa" of Greyson, Joseph, Cecelia, Lewin, Chloé, Maisy & 2 on the way. He also leaves several nieces, nephews, godchildren, and many cousins.

"Ray" (as he was known to family in his early years) grew up in Fall River, graduated from Durfee High School in 1940 and went on to Providence College as a member of the Class of 1944. It was during this time that he developed his talent for playing the saxophone under the tutelage of the father of the late Joe Raposo of Sesame Street fame. He began working at the family owned funeral home by age 13, back when services were conducted in homes.

His education was interrupted by World War II when he joined the army. Milt was deployed to Europe with the 120th Evacuation Hospital, which ultimately became internationally known for its role in the liberation of the concentration camp at Buchenwald and several others. It was an experience that always stayed with him and shaped his sense of justice, compassion, and fairness throughout his lifetime.

After the war, he married his high school sweetheart, Mary Gaspar, and finished his degree at Providence College. He went to embalming school and then joined the family funeral business, which he took over upon the unexpected death of his father in 1955.

He was a successful funeral director but always had a yearning to pursue a path in which he could serve others in the public realm. In 1950, with two children by then, Milton entered Suffolk Law School part-time. He graduated in 1952, passed the Massachusetts Bar shortly thereafter and the Federal Bar in 1955.

As an immigration attorney in a city with a high number of immigrants from the Acores, he made a huge impact on that community by taking a personal interest in many cases and going out of his way to help, even going to Canada at one point to intervene at the Consulate with a pending deportation due to a clerical error. Once the family was granted visas, he arranged for limousines to pick them up at Logan Airport. Subsequently, one of the minor children picked up that day ended up marrying his eldest son and becoming his daughter-in-law.

During this time, he became active in the credit union movement and became the founder of several credit unions. After retiring from the bench, he served on the supervisory committee of St. Anthony of Padua Credit Union until he was close to 90.

In between his two stints as Fall River Police Commissioner, Atty. Silva served in the State Legislature from 1960-1964. In that capacity, he served on a special committee to investigate a high-profile racing scandal. As a Republican serving in the minority during that time frame, he managed to work alongside the majority, led by his good friend and colleague, Democrat George Kenneally, in a collaborative and friendly way to serve the public interest. For this reason, he often expressed deep disappointment and frustration with the contentious and divisive atmosphere that he witnessed in recent years, especially at the national level.

Appointed to the bench in 1970, Judge Silva went on to serve for 20 years as the presiding justice of the Second District Court. During his tenure he oversaw a major addition to the Rock Street courthouse, the computerization of the court records and transactions and the creation of a district court jury system. Because of his keen understanding of the 1966 Miranda decision and the important rights awarded under that decision, he became known as "Not Guilty Milty," when local police departments were slow to implement it and got cases tossed out as a result. Judge Silva also created a "second chances" diversion program for first time offenders. He also served as chairman of the Committees on Preservation of Testimony and Caseflow Management; member of the Appellate Division of the District Court Department for the Southern District; president of the South East Regional Judges' Conference; and the faculty chair of caseflow management for the Judicial Institute.

Early on as a Judge, with the news reporting about a conspiratorial Holocaust Deniers movement, Milton began to open up about his time during the war (before then, not even his children were aware of his experiences). He devoted much of his limited free time to speaking publicly at countless school assemblies, synagogues, churches, community centers, etc. about the atrocities that he witnessed during WWII in order to try and impress upon the next generation the importance of bearing witness and not allowing history to repeat itself. He received recognition from several community Jewish organizations.

While a Judge and after he retired and in to his 90's he rekindled his love for music and joined the Swansea Community Band and the Providence Civic Orchestra of Senior Citizens.

Milt enjoyed playing squash at the YMCA and golf. A longtime member of Fall River Country Club, he also played in the Knights of Columbus League in Swansea and the Pine Valley Seniors in Rehoboth.

In recognition of his contributions to our area's Portuguese community, he received the first Benjamin N. Cardozo Award for Legal Excellence, as well as the Portuguese-American of the Year awards from both the Prince Henry Society & O Jornal. He was awarded the first honorary life membership of the Fall River Chapter of the Prince Henry Society. Milt was also a recipient of Durfee High School's Outstanding Alumnus Award. Several years ago, he, along with Silva-Faria Funeral Home, was honored with an exhibit of memorabilia at the Portuguese-American Archives at UMASS Dartmouth where many of his legal and judicial records are stored.

He was member of the American Federation of Musicians, Founders Club of CUNA, Amvets, American Legion and Knights of Columbus Swansea Council.

Still civic minded, after his retirement, he served on the Board of Directors for SerJobs for Progress for over 25 years.

DISTINGUISHED ALUMNUS GEORGE RAYMOND DUCLOS '52 OBITUARY



George Raymond Duclos, age 86, died peacefully on February 15, 2020 surrounded by his family. The son of the late Raymond and Albertine (Bertha Chenard) Duclos. Born in 1933 in Fall River, MA, George spent most of his life in Westport, MA spending summers on the Watuppa Pond and moving to the Pond permanently in the 1960's.

George is survived by his wife and life-long partner in adventure, Pauline D. (Duperre) Duclos, and his four children: John (Kimberly), Peter (Kimberly), Carol Hegarty (Steven) of Westport, MA, and Victoria Barrett (James) of Tiverton, RI; twelve grandchildren and two great-grandchildren, along with several nieces and nephews. In addition to his parents, George was preceded in death by his step-brother by kinship adoption Roland R. Chenard of Fall River, MA.

At 22 years old, George joined Gladding-Hearn Shipbuilding in Somerset, MA. With the support of his partners and his family (especially his wife, Pauline), George grew the business to become recognized worldwide as the premier builder of small commercial vessels including high-speed catamaran ferries, pilot and patrol boats, tugboats, and research vessels. The company had built nearly 400 vessels upon his retirement in 2011. If asked, he would say his greatest joy and

satisfaction came from working with his family and all the talented people at the shipyard.

Throughout his career, George was acknowledged for his success, including, an Honorary Doctorate from Massachusetts Maritime, a distinguished graduate award by Durfee High School, and as Small Businessman of the Year by the Small Business Administration.

When not at the shipyard, George and Pauline enjoyed their home on the Watuppa Pond, boating along the East Coast on their boat 'Gemini', or skiing in the White Mountains of New Hampshire. He loved to ice skate and ice boat with his Uncles and family. He and Pauline were one of the first to water-ski on the Watuppa Pond, behind his boat 'Dragon Bee Hind," built by George in his early teens. Most recently, he often shared that his great-grandchildren were the 6th generation of his family to swim in the Watuppa.

George was also an accomplished cabinet maker, crafting heirloom furniture for his wife and family.

George was very involved in the surrounding community. He was a founding parishioner of Our Lady of Grace Church in Westport, MA, Cub Scout leader in Westport Pack 100, founding member of the Fall River Marine Museum, founding member of the Watuppa Yacht Club, serving as Commodore several times, and a longtime member of the Bristol Yacht Club, where he served as Race Committee Chairman for several years. He was a frequent Race Committee member for all types of small sailboat racing on Narragansett and Buzzards Bays, on the Watuppa Pond and for the 1980 Olympic Sailing Trials in Newport, RI. He also spent many hours supporting his children's activities throughout the years.

The Duclos family extend a special thank you to the caregivers at Home Instead of Dartmouth, MA and Brookdale Sakonnet Bay of Tiverton, RI, along with other special people for their care and devotion to George over the past two years.

DISTINGUISHED ALUMNUS THOMAS J. CURRY, PH.D. '60 OBITUARY



Thomas J. Curry, Ph.D., age 77, of Swansea, passed away unexpectedly Friday, March 20, 2020 at Charlton Memorial Hospital. He was the husband of Carolyn E. (Sullivan) Curry to whom he has been married for the past 55 years.

Born in Fall River, a son of the late Raymond F. and Olympia M. (Conforti) Curry, he lived in Somerset for many years before moving to Swansea.

He was a graduate of B.M.C. Durfee High School, Class of 1960. An Electrical Engineer, he received his Bachelor of Science degree from UMASS Dartmouth, his Master's Degree from Worcester Polytechnical Institute and his Doctorate Degree from the University of Rhode Island and a Certificate in Manufacturing in the Corporate State from Harvard University.

He began his career at the Naval Underwater System Center in Newport, R.I. During this time, he was selected as the first Naval Science Advisor to the Admiral of the Submarine Force Pacific Fleet in Pearl Harbor, Hawaii. Upon returning from Hawaii with his family he joined Gould Ocean Systems Division as Director of Research and Engineering and led

all research efforts in small underwater vehicle guidance and control. In 1983 he became a Professor of Electrical and Computer Engineering at UMass Dartmouth. He was the Provost Vice Chancellor of Academic Affairs and the Dean of the College of Engineering, and before retiring in 2006, the Director of the Advanced Technology and Manufacturing Center at the UMass Dartmouth Campus in Dartmouth, Ma.

Dr. Curry was a communicant of St. Louis de France Parish, a member of the Atlantis Charter School Foundation and on the Board of Directors of the F.R.O.E.D. He was mentioned in the book 'Cream of the Crop' written by John Cummings as one of many accomplished Fall River natives.

Musically talented, he played many instruments including the guitar, organ, accordion and most recently the Ukulele. A lover of photography, cooking, gardening, traveling; he most enjoyed spending time with his daughters, grandchildren and his beloved wife Carolyn. He lived his life to the fullest.

In addition to his wife, he is survived by three daughters, Kathleen Curry Beaulieu and her husband James Beaulieu of Somerset, Kelly DiGiammo and her husband Andrew of Assonet, Kristin Curry of Somerset; eight grandchildren, Molly, Amy, Benjamin, Annie, Andrew, Alex, Ava and Galen and many nieces and nephews. He was the brother of the late Raymond J. Curry.

DISTINGUISHED ALUMNUS DR. LESTER W. CORY ' 56 OBITUARY



Dr. Lester W. Cory passed away on April 24, 2020, in the loving care of his family. He was born in Tiverton, Rhode Island on July 25, 1939, the youngest of three sons of Harold R. and Margaret G. Cory. He is married to the former Patricia Barrett. They have five children: Stephen Cory, Dyan Vaughan (John), Michael Cory, Melynda Viera (Richard Giguere), and Ann Vassiliadis (John); seven grandchildren: Jereme Beller, Cara Massey, Angela Viera, Samuel Chetwynd, Jacob Chetwynd, Emma Cory and Rachel Chetwynd; one great-grandchild, and many nieces and nephews.

Les graduated from Bradford Durfee College of Technology (now UMass Dartmouth) in 1963 with a degree in electrical engineering. He earned advanced degrees in engineering, science, and education from Northeastern University, URI (honorary D.Sci) and Bridgewater University. He is an honor graduate of the U.S. Air Force War College. Les served in the Rhode Island Air National Guard from 1957 to 1991 retiring with the rank of colonel. As commander of the 143rd Communications Flight and later of the 281st Combat Communications Group, his military awards include the U.S. Air Force Legion of Merit, the Air Force Meritorious Service Medal, and the Rhode Island Star.


Les was an accomplished professor of electrical and computer engineering at UMass Dartmouth from 1963 until retirement as Chancellor Professor Emeritus in 2008. He helped found and served as longtime volunteer Director of the SHARE Foundation; helping nearly 4,000 nonverbal individuals with disabilities to communicate. For this work, Les was honored by Ronald Reagan in 1985 with the President's Volunteer Action Award. In 1995 he was awarded a Jefferson Award and the National Jefferson Awards Committee included him as one of the 25 "Best of the Best" in the nation. Other awards and recognition included the UMASS Dartmouth Teacher of the Year Award (1985), President's Award for Public Service Award (2000), and UMass Dartmouth Chancellor's Medal for public Service (2014); the Fall River Chamber of Commerce Outstanding Community Service Award (1995); the Knights of Columbus Humanitarian Service Award (1991), and many others.

Les was also President of the Durfee Bells Preservation Society, a pilot, radio operator, choir member, and friend and mentor to many. Among his greatest achievements are the love and admiration of his family, friends, colleagues and the countless people whose lives were improved through his caring work and example.

VIETNAM VETERANS MEMORIAL WALL UPDATE

With the Covid-19 pandemic disrupting everyone's life, the Wall Project was not immune. The polished granite was scheduled to be here from overseas in May but the shutting down of the quarries and then the reduction in the number of vessels to transport the granite was reduced in half. Construction was stopped but what could be done continued. The podium and other Wall accessories continued to be discussed and designed. The 140 panels, which were already in our possession, were affixed by Collins Construction to the cement wall in a ceremony on September 17th. Some grading was necessary to bring the land up to the bottom of the panels and that was completed within 2 days. The first crate with the granite did arrive the week of October 12th and the 2nd crate arrived a few days later. The project is in another delay as we await the polishing of the granite at the mercy as to when the vendor can do it.





This will be done, and construction is expected to be completed by the end of 2020 with a dedication ceremony to be scheduled in the Spring of 2021 providing the Covid-19 protocol will permit it.

The building costing \$263 million is mostly new construction but there will also be renovations of the Luke Urban Field House. The Nagle Auditorium will be retained, which is the most westerly building. The Field House has been connected to the new construction by a walkway which will be glass sided. Because of the pandemic the work on the field house allowed Suffolk to get ahead of the original schedule.

The main school, Durfee V2, which was opened in 1978, will be demolished.

The Luke Urban Field House has gotten a major overhaul, new floor for Skip Karam Court, the fitness center will be a state of art training facility. The lobby has been doubled in size which will help the fans attending events. The Karen Jarabek pool has been renovated and will be up to regulation size.

The hallway ceiling tiles have not yet been installed and the systems of pipes, ducts and wires running through the school are visible. The framing for walls, doors and ceilings are metal, although more expensive than wood, will be better in cases of water contact. Extensive decorative wooden work will be in the finished product. There are many spaces that show floor to third floor ceiling views, showing the openness of the building.

Windows in the current building do not open, but Durfee V3 will have windows that will open only about 4 inches but will bring in fresh air when needed. There are two courtyards, one south and one north that will serve as outdoor education for arts and vocational students. There will be two cafeterias, one on the first floor and one on the third floor. The auditorium offers the stage area headroom sufficient to stage a Broadway show. Capacity 750.

The library will have the best views thanks to the large windows, there will also be a large amount of meeting space since the digital era requires less need for book space. Planetarium/ observatory will be high tech, which will be a revenue generator.

Multi-media/seminar/testing room is a 75-seat room which features viewing screen and will be able to host small theater productions. Shared glass small classroom space is positioned between two classrooms for students to take a makeup test in peace.

The culinary arts restaurant is being rebranded as The Granite Grill. Several large granite slabs were rescued from the waterfront and are being used in the schools' structure and landscaping.

2020, A DIFFERENT DURFEE GRADUATION!

A happy ending, graduation together for the Class of 2020.

Durfee seniors voted to replace 'hybrid' graduation with an in-person graduation later in the summer of 2020, seniors were willing to practice delayed gratification.

When Gov. Charlie Baker's four-phased reopening plan was announced, Desmarais said the wording concerning graduations was "vague," so the school department started to plan for a June 5th "hybrid graduation," which would have had graduates drive or be driven to Durfee, briefly leave the vehicle to walk across the stage and receive a diploma, and then return to the vehicle to exit school property. The event, running perhaps six hours, would have been broadcast online.

The Department of Elementary and Secondary Education announced schools could stage outdoor graduations after July 19. Some Durfee students quickly made their preference for the summer graduation known, and Desmarais put it to a ballot. Using student email and Google Forms, he polled the approximately

470 members of the Class of 2020. Students in Massachusetts have been banned from their school buildings since late mid-March.

Given the graduation options of a hybrid ceremony on the original date of June 5th or what should be far closer to a conventional ceremony after July 19, the Hilltopper Class of 2020 voted in favor of the summer option. The vote totals were 78 percent in favor of in-person graduation. Desmarais said voter turnout was about 65 percent.

"I'm pleased," Durfee Principal Matthew Desmarais said, "I can't give them everything back, but we can give them this. It's our duty to the students."

Noting that there is considerable brainstorming to be done in terms of date, time, and safety compliance, Desmarais said he expects to have the new graduation details worked out by early next week.

Seniors at Fall River's Resiliency Preparatory Academy also voted to postpone their graduation, Desmarais said.

BEVERLY ST. LAURENT ABEGG, BMC Durfee High School, 1960

You may have seen the Energizer Bunny on TV, but you have probably never met her. Beverly St. Laurent Abegg went to Henry Lord Junior High School before attending Durfee where she was a member of the band and orchestra playing first clarinet and oboe. During her high school career, she also the accompanied the Silvertones, a select group of girl singers.

After graduating from Durfee, in 1964 Beverly attended Boston University College of Music majoring in Music Education and upon receiving her bachelor's degree, continued at B.U. obtaining a Master's Degree in 1968.

Bev's public school teaching career began in Portsmouth, Rhode Island and later in the towns of Burlington, I'VIA and Westford, where she now resides.

Beverly's nonstop career included several jobs at once. In 1992 while she was office manager at the prominent Boston law firm of Nichols and Pratt. Simultaneously she was also administrator of The Merrimack Valley Philharmonic Orchestra which was comprised of professional and amateur musicians. The demanding job included: finding performance venues, negotiating salaries, locating and renting pianos as well as writing grants on a yearly basis to obtain major instruments such as tympani, chimes and electric keyboard. She engaged soloists from the Boston Symphony Orchestra as well as **Mu Phi Epsilon**, an International organization of professional musicians.

In 2008 Beverly was elected to the board of directors of MU Phi Epsilon becoming the treasurer from 2008 to 2017. Annually, the Foundation awards scholarships and grants to its members. Tri-annually, the Foundation sponsors an international competition and the winner is presented with a two-year contract to perform concerts throughout the United States. As the treasurer, Beverly arranges travel and pays an honorarium to the winner to help with miscellaneous expenses.
