#### **OLD BUSINESS**

## Road Report

Kevin has been spraying and Ronnie has been mowing. Bushard will let Kevin know how far signs need to be off the roadway such as speed limit signs must be 4 feet off the roadway and directional signs need to be 5 feet off the roadway.

#### **Gravel Update**

We are still applying gravel and are waiting for Hvezda to crush more rock before the next loads can be applied. Brown's Road has gotten really bad and Alex Lane has not been graded yet this summer. We need to check with Hvezda to see when we'll be getting more gravel. A motion was made that if Hvezda cannot get us gravel soon that we get some from whoever has some available. ## Grader Operator Class Update

Bushard and our maintenance operator attended the field portion of the grader operator class. It was very informative on topics such as how the grader should be operated, different methods of grading, how to build crowns and how to narrow a wide road by pulling the shoulders in.

#### Chloride Update

We have just a few left. We used up the first 4,000 gallons and ordered another 2,000 gallons which arrived July 3<sup>rd</sup>.

## Tree Removal Letter Update

We did receive letters back from Anderson, Howe and Foslien who gave us permission to trim tree larger than 6 inches in diameter in the right of ways.

### House Moving Tall Timbers

The house moving into Tall Timbers went well.

## Welcome Letter Update

Dave Rush did not want to start providing this additional information for us since they currently have 29 other townships and they do not want to set a precedent fearing that these special requests could continue to grow and become a burden on his staff.

### Johnson Tile

Bushard contacted Jerry Hagemiller letting him know that Arlan Johnson removed the standpipe from his tile and it is now at the same level as our drain tile to the lake. Jerry went and measured and found that Johnson's tile was in fact 7/10 of a foot lower than what it was when he measured it the first time. Jerry will be sending Johnson a letter telling him he needs to put the standpipe back on and if he decides he needs to drain water again he needs to contact Mrs. Wolf and Moe Township.

## Summer Short Course

Some of the items discussed at the summer short course was on data retention – what we can throw and what we need to keep, how to manage your traffic signs, open meeting law, hiring or electing your clerk and/or treasurer.
