The above described puppy/dog is guaranteed to be of good health at the time of sale. **Buyer agrees to have the dog examined by a veterinarian of their choice within (5) days of purchase to verify said good health.** Documentation must be sent to Paw Paw Puppy Tales within ten (10) days in order for the Health Guarantee to be honored. Failure to send documentation will render this Health Guarantee null and void. It is also noted that any & all vet bills are the buyers responsibly from the time of pick up. No guarantee is given to the future temperament, size, or color, of this puppy/dog. This puppy/dog is being sold for companion pet purposes and should not be used for breeding (unless otherwise agreed upon).

This puppy/dog comes with a "Happiness Guarantee". If the Buyer feels the need to return this puppy/dog within fourteen (14) days of the purchase date listed, a refund of the purchase price will be given up to 70% (seventy). Veterinary expenses, shipping, travel, etc. will not be reimbursed. This puppy/dog is sold with limited registration (unless otherwise noted). Buyer agrees to have the above described dog spayed/neutered (unless otherwise noted) after 6 months but not later than 18 months of the listed Whelp date. At no time does this contract cover communicable diseases, (Parvo etc..) parasites, retained testicles, or complications/death as a result of anesthesia, or neutering.

The extended guarantee covers the following defects and is valid for one (1) year from the listed Whelp date. \*Any defect of the heart that is life threatening, creates a murmur of grade 3 or more, or requires life-long medication. A congenital liver shunt. Any inoperable inherited defect that diminishes the dog's quality of life to the point that the best recourse is euthanasia. In the event that the dog is conclusively diagnosed with any of the listed conditions by a licensed veterinarian the buyer must supply copies of the associated reports to the breeder. The breeder reserves the right to obtain a second opinion at the breeder's expense. After said reports have been verified by Breeder, the Buyer has one of two options:

1.) Buyer can keep the dog; at which time Breeder will reimburse Buyer the full purchase price of the dog. Any additional expenses, beyond the original purchase price, incurred during the lifetime of the dog, would be the responsibility of the Buyer. In the event of the later death of the dog for any reason, no other reimbursement or replacement will be given. Any refunds given are minus any rebates already paid for AKC Puppy/Canine Good Citizen certification fees.

2.) The Buyer can return the dog to the Breeder for a replacement (no refunds) that Buyer and Breeder agree on. Replacement will be made from any currently available dog/puppy or the next

available litter equal to purchase price. Veterinary expenses, shipping, travel, etc. will not be reimbursed. All AKC registration, veterinary records, etc. must accompany the returning dog.

Should an inherited defect cause the unexpected death of this dog within one (1) year of the listed Whelp date, Breeder agrees to provide a replacement that Buyer & Breeder agree on. A necropsy report with conclusive findings must accompany any request for a replacement. Replacement will be made from any currently available dog/puppy or the next available litter. All expenses incurred for the necropsy will be paid by the Buyer. Should an inherited defect cause the unexpected death of this dog during the period between two to four years of age, 25% of the original purchase price of the dog, would go towards another Paw Paw Puppy Tales puppy/dog. A necropsy report with conclusive findings, paid for by the Buyer, must accompany any request for the discount. Buyer agrees to notify Breeder immediately of any diagnosed health issues or death of the dog. Breeder may opt to pay for a necropsy for their own information if buyer declines to do so. In the event Breeder pays for necropsy, all information is the property of the Breeder and any possibility of a replacement/refund/discount is void.

Buyer agrees that if at any time during this puppy/dogs life they cannot keep the dog the Breeder will be contacted immediately and must be a part of the re-homing process. Under NO circumstances may this dog be re-homed to any individual or organization not approved by Breeder. In the event of no suitable re-homing option being available, the Buyer shall transfer ownership to the Breeder and return the dog along with all AKC registration papers and veterinary records, who will care for it until a suitable home is found. Breeder is allowed to charge a rehoming fee.

Buyer agrees to provide housing indoors, to keep the dog clean and frequently groomed and to provide the dog with a proper diet. When outside, the dog should be confined in a securely fenced yard or walked on a leash. Obesity, malnutrition and/or poor hygiene constitute abuse/neglect. If the dog is found to be allowed to run freely, running at large, creating a public nuisance, or found to be neglected, abused or allowed to live in poor health or conditions the seller has all rights to repossession of this dog with no refund to the buyer. The death, injury or loss of said dog due to theft, carelessness, recklessness, abuse, neglect, heat stroke or accident will not entitle the buyer to any compensation from the seller. Remember that many Veterinarians consider dogs aged 8 years and above a "senior" and health issues are not unlikely. We hope that you enjoy many wonderful years with your Paw Paw Puppy Tales puppy/dog and will return to us for another when you are ready. Please note this Contract is two (2) pages long and is agreed upon by both parties and able to be used in a court of law.
