



**COMMONWEALTH OF DRACUL  
PROTECTORATE APPLICATION**

**COVER PAGE**

The Commonwealth of Dracul's Department of State successfully maintains a professional demeanor and atmosphere when it comes to diplomacy with other micronations. It should be fully known and understood that Dracul is a serious micronation, that does not conduct nor condone simulations, pretend wars, fake population numbers, fake history, or anything to appear to others as "fantasy", "roleplay", or "gaming". If any of these descriptions apply to you, please do not apply for protectorate status.

As a protectorate of the Commonwealth of Dracul, your micronation will be under the direct supervision of Dracul's Department of State, in conjunction with the Office of the President. All communications between a protectorate and Dracul must always be kept professional, including the method of contact (no social media messaging). A protectorate, while not considered specifically an ally, must still adhere to the diplomatic requirements, listed on our website. Those who are ineligible via diplomatic requirements will also be denied protectorate status (no exceptions will be made). **YOU MUST ATTACH A COPY OF YOUR CONSTITUTION WITH THIS APPLICATION PACKET!**

**The Commonwealth of Dracul informally recognizes all micronations.** If a micronation wishes to establish full recognition and a treaty of friendship, they must be willing to adhere to our requirements. Exceptions cannot and will not be made:

1. The requesting micronation must be in existence for **at least 6 months**. In addition, the micronation must not have drastically changed their government style within **the past 3 months**.
2. The micronation must have a website or social media account, explaining their government style, leaders, and citizenship information. Information must show progress from the start of existence.
3. All micronations must make reasonable claims. Dracul will not establish an alliance with a micronation that claims land of an entire city, state, county, or country. In addition, the micronation cannot claim an entire population without the people's knowledge.
4. **The micronation must physically exist.** Micronations that exist virtually, have fake history, inaccurate population, or claim land on other planets will not be approved.
5. Any micronation that has inconsistent data with their history will be under further review, pending the treaty acceptance (i.e. existing since 2018, but having only 2 citizens).
6. Dracul will not engage in diplomacy with micronations that declare war on each other, hold terroristic ties with others, or who seriously declare war on U.N. recognized countries.
7. Any micronation that acts in an unprofessional manner, does not hold true dedication, uses copyrighted images as their own, or targets legally protected groups will not be approved.
8. Dracul will not discuss diplomacy with micronations who operate in a Marxist, Leninist, Nazi, or Anti-Semitism style.

*In addition to meeting the standard diplomatic criteria, a protectorate applicant must also adhere to the protectorate criteria as well. Those who violate the requirements will also be stripped of their status and all negotiations between Dracul and the protectorate, ceased.*

## **PROTECTORATE CRITERIA**

Revised May 27, 2019

The Commonwealth of Dracul will assist any micronation in need of assistance, especially pertaining to economics, government control, and other major common issues. For an applicant to be approved, they must fully meet the "*Protectorate Criteria*". Exceptions cannot and will not be made:

1. The applicant must agree to maintain constant communication with Dracul's Department of State. Email is the preferred method of contact. In addition, all communications must be kept professional, with little to no general chatter.
2. Any decisions made by Dracul's Department of State towards the protectorate, must be fully adhered to, without delay. Should an issue arise following the order, communication must be established with Dracul as soon as possible.
3. A protectorate cannot at any time, claim a treaty with or "favored nation status", unless Dracul's Department of State has specifically granted such.
4. A protectorate will refrain from declaring any "micronation wars" with others. Furthermore, any conflicts with other micronations must be brought to the attention of the Secretary of State, who will in addition, relay this to the Department of Local Defense.
5. A protectorate must be willing to send a representative to the Draculian Parliament, via online messenger, once a month, to participate in and discuss matters within the Parliament. This representative will be a non-voting member in all matters pertaining to the Commonwealth.
6. The protectorate must not change their form of government without the approval of the Dracul Department of State.

In addition to meeting these two criterias, the applicant must fill out a questionnaire on the next page, to be considered. Any inaccurate or false information will result in disqualification.
