As a follow-up to the March 29th review of extracted data from the cell phone of Katherine Morris (performed in Las Vegas by Expert Data Forensics) she writes:

".. As some or most of you may now be aware, March 29 was a long, grueling, emotionally charged day. Most of all it was a PRODUCTIVE day. Four of us, with two very special assistants, put in ten hours each on five computers. The result was forensic evidence -- objective, not subjective -- that Katherine Morris's cell phone ping locations are completely inconsistent with the time, place and determined method of her death.

While her car had NOT MOVED, her phone took quite a journey. The report that was generated is black and white. The autopsy allowed a 24 hours window for time-of-death. The cell phone movements were tracked for that time period and intense attention was focused on the approximately 8-9 hours prior to discovery of her body in her car in the mall/movie parking lot,

Katherine Sarah Morris, March 11, 1990 - May (5 or 6), 2012, did NOT commit suicide in that Anne Arundel mall. She did not send the suicide notes. There is another explanation and more than one person involved. Rev Morris received the copy of the forensic evidence and has brought it back to Baltimore.

That evidence was extracted by Leon Mare, certified nationally. The company name that donated these services via FFA is Expert Data Forensics. Their telephone number is 702-435-8885. There is nothing Maryland specific involved. Data is data and you can see exactly what we were able to see.

We ask that you REOPEN this case immediately.

We ask that the cause of death be changed from SUICIDE to UNDETERMINED.

We ask that this occur PRIOR to the 5/5/15 expiration of the Statute of Limitations.

If you have any doubts about this process, it was video recorded by 20/20 cameras. By the time this video is released, it would be nice if Anne Arundel County PD was doing its job and thoroughly investigating this HOMICIDE.

In the spirit of cooperation, FFA will assist with the sharing of expert conclusions in those many areas of concern previously voiced. Our own investigation continues.
