Secretary Shinseki's 2nd letter released to public- Cease and Desist Treasury Offset program for 90 Days.

What's happening....

♦ Veterans Educational Counseling Transparency in Opportunities and Resources (VECTOR) Act of 2013. (Representative Chu)

This bill aims to ensure that all GI Bill-eligible veterans applying for benefits are made aware of the free educational counseling available to them by the Department of Veterans Affairs (VA) before receiving their certificate of eligibility.

now....

 ▶ H.R. 813, The Putting Veterans Funding First Act of 2013 (Representative Miller)

This bill would require Congress to fully fund the Department of Veterans Affairs' discretionary budget a year ahead of schedule, ensuring that all VA services will have timely, predictable funding in an era where continuing resolutions and threats of government shutdowns are all too frequent.

And....

Honoring our Promise to America's Veterans Act (Mr. Culberson) Passed October 1, 2013 Joint Resolution

This bill would ensure that veterans in receipt of VA disability compensation, pension, GI Bill, and other critical benefits will continue to receive those benefits in the event of a prolonged government shutdown. The bill would also fund the Veterans Benefits Administration at President Obama's fiscal year 2014 requested operational level, ensuring VA claims processing efforts could continue at normal rates.

And Again....

• "Protecting Those Who Protected Us Act of 2013". (Mr. Sanders)

There are hereby appropriated for fiscal year 2014, out of any money in the Treasury not otherwise appropriated for any period during which interim or full year appropriations for fiscal year 2014 are not in effect, such sums as necessary to administer and provide benefits and services to veterans, dependents and survivors under chapters 11, 13, 15, 18, 21, 23, 30, 31, 33, 35 and 39, of title 38, United States Code.
