

Last month we wrapped up our study on Revelation and the End Times - a very good book and study. It was a great turn out from both churches but I realize that was just a small percentage of those who receive this newsletter. So, I want to share some of the new insights and takeaways from this book. This book answers those questions we have about: what happens to us when we die, when is Jesus coming back or at all, and are we living in the end times or is that a future event?

First off, the end times started two thousand years ago with Jesus's birth, life, death and resurrection. Many want to believe that there is much of biblical prophecy yet to be fulfilled when much of it was fulfilled in Jesus' lifetime or shortly thereafter. Granted, some of it has yet to be fulfilled but much of it has already taken place. Most of the prophetic books are in the Old Testament and the only New Testament book is Revelation. This is why perhaps the New Testament writers did not feel the need to write about prophetic events because they had or were already taking place.

What happens when we die? Do we immediately go to heaven and be reunited with Grandma and Grandpa? It is important to think of how the Apostle Paul describes what happens to us – whenever we are absent from the body, we are present with the Lord. If we die before Christ comes back again, that heaven will only be temporal because we will come down to earth with Christ and be a part of the new heaven and the new earth. God will set-up the kingdom on earth and it will be restored to "Eden-like" conditions. Is that different from what you grew up hearing?

When is Jesus coming back again? No one knows, not even Jesus himself - only the Father knows. Yet, that doesn't stop people from predicting and trying to find some sort of clue in Revelations or one of the Old Testament prophetic books. The one clue that we are given is that it will be quickly. Too often that has been translated as soon but it means quickly like a thief in the night. All of a sudden, without any warning – Christ will come back again. I hope this piques your curiosity and if you want to pick up a copy of this book there are a few left at each church and when those are gone, we can order more. As always, if there is something you want to know more about – let's have a conversation.


