Course Training Agreement

Services provided: Sessions will be taught by Emily Gaydos, dba The Clicker Coach ("Trainer"). Working sessions are limited to 8 dog/handler teams so personal attention may be provided to each team. Trainer, at her discretion, may refuse entry to any dog that is or seems unsafe, unhealthy, or which in any way does not seem suited to the services offered

Payment: Payment is due prior to the start of the course.

Rescheduling/Cancellations: Due to the nature of the course, it is not possible to reschedule lessons. No refunds will be given for missed sessions.

Removal from training: Trainer may, at her sole discretion, remove a pet from class if a hazard or threat of any nature to any other animal or person is present. No refunds will be given under such circumstances.

Danger to Trainer: This class is not suitable for dangerous dogs. A dangerous dog is here defined as any dog which has bitten a person or other animal, or which has shown signs of attempting to bite, and which in the judgment of the trainer cannot be safely and appropriately managed in the course setting by the owner/handler. Owner agrees that he/she has represented the history of the dog accurately and truthfully. Failure to notify Trainer of dangerous behavior from owner's pet prior to or during the period of training will result in immediate cancellation of all sessions with no refund.

Assumption of Risk: Classes will be held in a location deemed suitable by the Trainer. Owner agrees to indemnify and hold the Location, its employees and agents and Trainer harmless from all liability for any loss, damage, or injury to persons, animals or property arising from or related to Owner's pet or other pets in class. Owner agrees that Location and/or Trainer shall not be liable for loss or damage to said animal, persons, animals or property unless said loss or damage was a direct result of Location and/or Trainer's negligence.

Arbitration: Any controversy between the parties involving any of the terms, covenants, or conditions of this Agreement shall be submitted to arbitration in Siskiyou County, California, on the request of any party, and shall comply with and be governed by the provisions of the American Arbitration Association. All decisions shall be final and binding. In any dispute between the parties, whether or not resulting in litigation, the party substantially prevailing shall be entitled to recover from the other parties all reasonable costs, including without limitation, attorney's fees.
