# ALL TERRAIN VEHICLE and UTILITY VEHICLE ORDINANCE

AN ORDINANCE TO REGULATE THE USE AND OPERATION OF ALL TERRAIN VEHICLES and UTILITY VEHICLES IN THE TOWN OF NIAGARA AND FOR THE PURPOSE OF ACCESS TO ALL TERRAIN and UTILITY VEHICLE TRAILS IN AND OUT OF SAID TOWN.

The Town Board of Niagara, Wisconsin does ordain as follows:

#### SECTION I.

The state All Terrain and Utility Vehicle laws are adopted. Except as otherwise provided in this ordinance, the statutory provisions and defining regulations with respect to All Terrain and Utility Vehicles in the Wisconsin statutes are hereby adopted and made part of this ordinance as is fully set forth herein. Acts required to be performed or prohibited by such statutes are required by this ordinance.

### SECTION II.

All Terrain and Utility Vehicle routes are to be so designated. The following roads in the Town of Niagara, Marinette County, Wisconsin are hereby described as all year round All Terrain and Utility Vehicle routes:

- A. Provencher Rd.
- B. Barlow Lake Rd.
- C. Brown Spur Rd.
- D. Spike Horn Rd.
- E. Wescher Rd.
- F. Chapman Rd.
- G. Morgan Park Rd. (Pem Bon Won River Bridge to Town line)
- H. Penrod Rd.
- I. Hazard Rd.
- J. Rattie Rd.
- K. Barton Bird Rd.
- L. Old 8
- M. Echo Lake Road (contingent upon signage provided by resident seeking permission)
- N. Wishman Road
- O. Zaidel Rd.
- P. Towns Rd.
- Q. West Rd.
- R. Johns Rd.
- S. Valerio Rd.
- T. Perry Rd.

## SECTION III

All other action hereto enacted by the Board of Niagara which is in conflict with this ordinance is hereby repealed.

#### **SECTION IV**

Limitations. Operation of All Terrain and Utility Vehicles on the foregoing designated routes shall be subject to the following limitations:

- A. All Terrain and Utility Vehicles shall be operated on the extreme right side of the roadway.
- B. Left turns shall be made as safely as possible from any position depending on snow cover and other prevailing conditions.
- C. All Terrain and Utility Vehicles shall make a complete stop before crossing unplowed Roads.
- D. All Terrain and Utility Vehicle operators shall yield the right-of-way to other vehicular traffic.
- E. All Town of Niagara roads which are open to ATV, UTV, and snowmobile will open and close coinciding with Marinette County trail openings and closings.

#### SECTION V.

This ordinance in effect per unanimous vote of the Town Board of Niagara on October 13, 2004. Rights granted herein to be in effect indefinitely unless notice if intention to rescind given to concerned parties thirty (30) days prior to doing so.
