CRITERIA & GUIDELINES

Chrysalis to Butterfly Mask Contest

- Entries must address the theme: How are you using the elements of art and the principals of art. The life cycle, comparing types of butterflies, symbols and mythologies. Entrants must be age 19 or older and the parent or guardian of a child who falls into one of the grade categories below and has created an entry on the contest theme.
- 2. Submissions can be a drawing, video or essay for Chrysalis to Butterfly mask contest.
 - **a.** Drawings must be done on an 8½-inch by 11-inch sheet of paper.
 - **b.** Videos must be uploaded to YouTube.
 - c. Essays must be 300 words or less.
 - **d.** Masks must be sent to address, designated, below.
- 3. All works submitted must be the original work of the child.
- **4.** All entries must include the child's name, address, age and category (see below), and the parent/guardian name(s), email address and phone number. (Email address/phone number will be used for contact only in conjunction with the contest.)
- 5. Only one entry is allowed per child.
- **6.** All entries will become the property of INCAMEI will not be returned.
- **7.** All entries must be received by 11:59 p.m. Eastern time, January 30, 2021. Mailed entries must be postmarked by 11:59 p.m. eastern time, January 30, 2021. Late entries will not be considered.

CATEGORIES: Entries will be judged in five grade categories.

- Category 1: Pre–K and kindergarten
- Category 4: Grades 7–9

· Category 2: Grades 1–3

· Category 5: Grades 10-12

- Category 3: Grades 4–6
- 8. Start date: December 10, 2020. End date: January 30, 2021.

JUDGING: Up to three winners in each age category will be selected by a team of artists based on:

- · Ability to create a compelling message.
- · Ability to present the message (capture the contest theme) in a unique way.
- Pre K-K will receive a prize for effort. Parents and teachers may help.
- Instructors will receive a gift for entering their class(s).

PRIZES: Winners will be announced by Curator **Selection:** On or Before February 7, 2021. The top three (3) drawings, three (3) videos and three (3) essays in each age category will receive an award and a certificate of recognition. All winning entries will be shared at international chrysalis.org/contest and may be included, in part, in the February website.

SUBMIT YOUR ENTRY:

- All essays must be submitted online, to email of INCAMEI. Please fill out information completely and attach your submission.
- · All videos must be uploaded to YouTube and entrants must share the video URL to the email address.
- Drawings may be submitted to email address or they may be mailed. If mailing, be sure to download and include the entry and consent form. Any artwork shipped needs to be paid for by shipper or sponsor of artist. You must be the creator of the art and image you or your approved representatives submit to the competition.

TERMS & CONDITIONS

INCAMEI Chrysalis to Butterfly C o n t e s t

ELIGIBILITY: The contest is open to legal residents of the United States (excluding Puerto Rico) who are 19 years old or older, who are the parents or legal guardians of children ages 3 to 18, and who submit work created by those children. Each eligible adult who participates in the contest is an "Entrant." Each Entrant may submit only one entry per eligible child. The contest is subject to all applicable federal, state and local laws and regulations; it is void where prohibited by law.

AGREEMENT TO OFFICIAL RULES OF THE CONTEST: By submitting an entry in this contest, each Entrant agrees to follow and be bound by the Criteria and Guidelines, these Terms & Conditions, and the media release (collectively, the "Official Rules of the Contest"). Sponsor reserves the right, at its sole discretion, to qualify all entries and to reject any entry that does not appear to meet the requirements for participation, as set out in the Official Rules of the Contest and solely interpreted by Sponsor.

JUDGING AND SELECTION OF WINNER: All winning entries will be selected on or about February 7, 2021. Winning entries will be selected from among all eligible entries received by a panel of qualified independent judges engaged by Sponsor. Eligible entries will be evaluated according to their ability to create a compelling message and ability to present the message.

Capture the contest theme in a unique way. The decisions of the judges are final and binding. Sponsor reserves the right to not award any or all prizes if, in its sole discretion, it does not receive a sufficient number of qualified and eligible entries.
