STATEMENT OF AFFIRMATION FORM

Ketchen Lake Bible Camp is a distinctively Christian organization. Our policies are built on principles taken from the Holy Bible. The Scriptures are the final authority guiding our faith and actions. Our understanding and interpretation of Scriptures is consistent with the evangelical Christian tradition. We expect all KLBC staff and volunteers (referred to as staff in this document) to believe and follow our Statement of Faith and Code of Conduct.

We believe:

1. The whole Bible is inspired by God and therefore our authority for faith and practice.
2. The Trinity is one God: Father, Son and Holy Spirit.
3. Jesus Christ is God and was miraculously conceived, performed miracles, died and was buried, physically rose again, ascended to heaven and will return.
4. In the person of the Holy Spirit, whose ministry is to glorify the Lord Jesus Christ, convict mankind, renew the believing sinner, indwell, guide, instruct and empower the believer for godly living and service.
5. In the total sinfulness of mankind and that only by being born again through faith in our Lord Jesus Christ alone can we have salvation.
6. In the resurrection of our body, the eternal life of the saved and the eternal punishment of the unsaved.
7. In the existence of Satan, a created being and an enemy of God.

Ketchen Lake Bible Camp Staff are expected to function as Christian leaders, upholding New Testament standards in all aspects of life and ministry. Applicants to Ketchen Lake Bible Camp do not qualify for a place of ministry if they do not intend to adhere to the Code of Conduct.

1. Because Ketchen Lake Bible Camp Staff function as highly visible role models and servant leaders within our community of ministry, their lives must be consistent with the faith we represent. KLBC Staff hold positions of authority and that authority must never be abused.
2. Ketchen Lake Bible Camp Staff are expected to establish the spiritual disciplines needed to maintain and promote a deep, intimate relationship with God.
3. Staff are to be careful, responsible stewards of Ketchen Lake Bible Camp property.
4. Alcohol and illicit drugs are not allowed on Ketchen Lake Bible Camp property.
5. Ketchen Lake Bible Camp Staff are required to avoid conduct that is unethical or immoral and to avoid behaviour that is contrary to biblical principles

CRIMINAL RECORD CHECK PROCEDURE FOR EVERYONE 18 YEARS AND OLDER

Outlined below are step-by-step instructions to help you complete your mandatory criminal record check:

1. Visit www.backcheck.net/cca and click on Saskatchewan Camping Association. Select SCA - Ketchen Lake Bible Camp from the list of camps provided.
2. You will need to register for a myBackCheck account and create a username and password.
3. Once registered, you will receive a confirmation of registration e-mail from myBackCheck.com. Open it and click on the web link to activate your myBackCheck.com account.
4. Type in your username and password to log in. Once logged in click on the 'Inbox' tab at the top of the page to find your Invitation.
5. Click on the CCA Invitation, which will allow you to click 'Accept and Continue' to move forward with your check.
6. Continue with the steps and pay online by credit card (\$29 plus tax – if applicable).
7. After the purchase is complete, click on "my Account" and then click 'Continue' to proceed with the criminal record check.
8. Enter your identity information.
9. Disclose any criminal records. These details will be used by the police department to verify any potential record you may have, so remember to be as accurate as possible.
10. Review the Term and Conditions.
11. Verify your ID online, or if you do not pass the ID online process, print the Canada Post ID Verification Form and take it to your nearest participating Canada Post location to have your IDs verified and submitted to myBackCheck.com. No money needs to be given to the Canada Post representative as this payment is included in the initial fee through the myBackCheck.com site.

That's it! Results of your check will be processed and the results released within one business day. Your results will be shared with SCA - Ketchen Lake Bible Camp at the same time that they are released to you.
