Special Town Meeting

- 1. Call to order & Pledge of Allegiance
 - a. The October 18, 2022 special Town Meeting was called to order at 6:00 PM
- 2. Confirm everyone has signed poll listing
 - a. It was confirmed that there were 12 town electorate in attendance. See attached poll list
- 3. Town residents approve agenda
 - a. MOTION (LaLiberte/Jim Hallgren) to approve the agenda as presented. Motion carried. No negative votes.
- 4. Approve the 2022 total town tax levy to be collected in 2023 pursuant to s.60.10(1)(a) of Wis. Statutes,
 - a. MOTION (LaLiberte/Liebergen) to approve the 2022 town tax levy to be collected in 2023 of \$66,288 as allowed by the State of Wisconsin on the 2022 Municipal Levy Limit Worksheet. Motion carried. No negative votes.
- 5. Establish the compensation for elected town officers pursuant to s. 60.10(1)(b)1, Wis. Stat. including stipends and any extra wages for duties outside the statutory scope of office. Any changes will become effective for officials elected with the start of the new terms in April 2023.
 - a. MOTION (Hallgren/LaLiberte) to approve the compensation of all elected officials for a 5% increase of the current wage starting April 2023, after the annual meeting, and until April 2025, before the annual meeting. This equates to the following new annual wages: Clerk, \$11,139; Chairman \$5,141; Supervisors \$3,358 each. Motion carried. No negative votes.
 - b. MOTION (Hallgren/LaLiberte) to approve the stipends for meetings set at \$30 per event. Motion carried. No negative votes.
 - c. MOTION (Liebergen/Neil Johnson) \$15 per hour for small town duties outside statutory requirements (i.e. determine security deposit after hall rental, handle downed trees, etc.) Motion carried, No negative vote.
- 6. To discuss and act upon the request for the Town to seek the county sell a parcel of land (020-00223.004) to the Town of Niagara once it is in foreclosure, with the intent that the town will sell the parcel to the owners of one or more of the adjacent parcels.
 - a. MOTION (LaLiberte/Liebergen) to purchase the land (020-00223.004) once in foreclosure from the County and then sell the parcel to Andrew Angus, who will split the parcel according to the old understanding of the

parcel lines. Andrew Angus agreed to pay all costs and the town electorate has agreed to sell this parcel, once in town ownership, to Andrew Angus. Motion carried, No negative vote
