## SB1269: School Funding Formula

## Bill Spotlight SB1269 (Striker): Conformity; Internal Revenue Code <u>Bill Summary</u>

Establishes the State Student Funding Formula (state formula) and details funding, tax levy and budget calculations for charter schools and eligible school districts. Modifies the standard school finance formula (standard formula).

Arizona is a leader in providing educational options that put students first; however, our current funding structure creates huge disparities from school to school depending on the type (charter or district), and whether or not the district is able to convince voters to add additional money through bonds, overrides, or tax increases.The current funding formula was established in the 1980s and is in drastic need of change. The strike everything amendment to SB1269 provides this essential student-centric funding update!
