## **Public Hearing:**

- **Rezoning Application:** *a tract of property located at or near 2025 S Duquesne Road from R-1 to C-1*. Terrie Burton is here to request that their property be rezoned from R-1 to C-1 in order to sell the property. Van Benson (owner of four properties adjacent to the north) is in favor of this. Motion to send rezoning recommendation to city council, Reeve/Gamboa 6-0
- Proposed ordinance amending Title IV: Land Use, Chapter 404: Zoning Regulations, Subsection "A" to provide that in the "R-1" single-family district, churches and other places of worship, but excluding overnight shelters, are permitted uses.

The board discussed meaning of overnight shelters. Chris Ellsworth helped clarify what the ordinance meant. Reeve thinks the wording of the amendment is strange. The ordinance was looked over by the mayor, the council, and the city lawyer. Connie Moore questioned why this was brought up to be amended. Chris Ellsworth responded that many council members had been approached by Duquesne citizens regarding it. The goal of the ordinance amendment is to help clarify the existing code.
