Call to Order: Meeting was called to order at 7:00 p.m. Chair Caroline Murphy presided. The opening statement was given. Notices were properly published and posted.

Craig Nelson: Fire District: Business as usual. Ken Vergauwen, Chief/Inspector, is retiring October 1.

Mark Jensen: Park & Rec: Update on Fund 80. If it goes through Farmington would go up to \$62,771, but it is not guaranteed for 10 years, school board is addressing. 0% increase in budget right now.

Caroline Murphy: Lake District: Annual Meeting, Presentation from Onterra & DNR is treating areas for invasive species plants.

Wisconsin Towns Association Quarterly Meeting in Manawa: Command Central voting machines costing \$8200 starting cost. This new machine is combination of paper and touch screen. Mark Sether, County Treasurer, is organizing a training, October 25. Casey Beyersdorf, Waupaca Highway Commissioner, Trip (money) towns can apply for money. Farmington's roads are too good to qualify for Trip (money). Town will apply again for Trip for Larson Road.

Phil Durrant: Concern for invasive species including Eurasian Watermilfoil and treatment of it on Limekiln lake by marina.

W. Silver Lake Rd has been let go. Section of Ottman Dr. has a big dip causing water to puddle. Costs to repair are \$13,000 for W. Silver Lake Rd and \$4,500 for Ottman Dr. Amendment is to change budget for funds from Committed Road Funds to Highway Maintenance Funds in the amount of \$17,500. See Attached. Farmington pays \$61,578 to Park & Rec. Fund 80 would change this to \$62,771. Town currently has a 1-year agreement. Because the 3-year agreement increased for 2018: \$69,034 and 2019 \$76,491. Non-resident fee is \$193. Farmington has 246 children participating in 513 programs. Fund 80 is a school board decision.
