The clerk had only received about 30 requests to date for dust control. Anderson's from Mill Lake Resort were present to ask the board to consider spraying from Highway 27 to well past the resort. We had almost everyone along that stretch that had requested it already so the board decided to apply it from Highway to about Bob Neubauer's corner.

#### Tractor Lease

We were told out tractor lease this year would be the same as last year but then they came back and said they they increased it to \$4,000 rather than the \$3,500 we paid last year. We'll see if they'll meet us in the middle at \$3,750.

It was explained that the County controls that and the Township does not have anything to do with. Nonetheless the County was asking them to get resolutions from the townships, both La Grande and Moe.
