



2021-2022 SCHOOL YEAR Dress code policy

The following information addresses VCLA's dress code policy and expectations. Please review and acknowledge your understanding by signing your name below. A copy can be provided at your request.

The Dress Code Policy in effect is for the sole purpose of preparing VCLA students for the real world. This Dress Code policy will be strictly enforced every day and for all school-related activities. Students who are out of compliance with the dress code will not be allowed to enter school campus. All uniforms must be purchased through the French Toast website. Please refer to attachment for instructions on how to access the site or visit the school website at vcla-polk.com for more information. Please order according to your child's biological gender and size.

Here is a list of the 2021-2022 Dress Code updates:

- The school logo colors are white and green only (gray, black, and white polos from previous year cannot be worn)
- Only tan khakis bottoms will be worn. (black, blue, and gray bottom or khakis are no longer permitted)
- There is a designated Chapel Day uniform. All students will wear button down yellow oxford shirts with tie. Boys will wear khaki pants and girls will wear knee-lengths skirts. Students will remain in the chapel day uniform for the entire school day.
- Girls will only wear skirts on Wednesday. It is strongly encouraged that tights/short be worn underneath skirts for all ages.
- All polos must be tucked in and secured with a brown or black leather belt. All students must wear leather belts.
- There is a designated Friday uniform. Students will wear the Pioneer T-shirt and blue denim jeans (no rips, tears, patches, patterns or frays).
- Tennis shoes are permitted in ALL black only (no colorful laces, red stripes, blue lines, colored logos/brands or accents).
- Loafers are permitted in all black, tan, or brown.
- Students are permitted to wear the black winter jacket, if previously purchased. No other Jackets or sweaters will be permitted. School uniform now includes a cardigan (jacket) that can be purchased on the website.
- As the winter season approaches, the school uniform website will include a winter catalog.

VCLA will provide notifications if there is any dress code allowances or changes for any school activities or events. Otherwise, students are expected to follow guidelines described above.

By signing, I/We signify that I/we have read, understand and agree to the dress code policy noted above. I/We have communicated this policy to my/our child and he/she she is aware of this policy. I/We understand that my/our child must have on the proper shirt, bottoms and shoes to be in compliance with the school dress code policy. If my/our child is out of dress code, I/we may be required to bring proper clothing or pick his/her up. Additionally, I/we understand that if consistent dress code violation persists, it may result in disciplinary actions.
