Connellsville City Council MINUTES MAY 21, 2019

This regular meeting of the Connellsville City Council was held this evening at 6:00 PM at City Hall, Connellsville, PA. Attending this meeting was Mayor Lincoln, Council members Keedy, Karpiak, Tzan and Topper. Also attending was City Clerk Ohler and Solicitor Witt.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Pastor Clark led prayer

REMARKS FROM VISITORS/PUBLIC COMMENTS:

Resolution No. 5-1-2019: "To grant Girl Scout Troop #52945 permission to install and maintain a small "Community Garden" at Pinnacle playground."

Meredith McCutcheon, Truck traffic on Snyder Street and Crawford Avenue

Mayor Lincoln explained that he was made aware of this issue and questioned if the City can limit the trucks to enter and exit the City during certain hours. He directed the City Solicitor to explain.

Solicitor Witt explained Snyder Street and Crawford Avenue are both State roads therefore the City cannot control what traffic can be on those roads. He further noted that PennDOT has the ability to put restrictions in place.

McCutcheon reiterated on her complaint.

Solicitor Witt explained the ordinances she is referring to are not traffic ordinances. He stated the Jake Brake Ordinance is for City and Public Streets. He further reiterated State Roads must go through PennDOT.

Mayor Lincoln questioned Tom Currey concerning the noise ordinance.

Currey explained that is for residents at their property. He suggested McCutcheon talk to Rep. Ryan Warner's Office or Senator Stephano's Office, noting they have the power and influence over PennDOT.

Police Chief Hammerle added the Police Department can issue citations for the Jake Brakes.
