Investigating Child Abuse

Target Groups

The course is aimed at all those who are employed to investigate child abuse including Social Workers and Police.

Recent cases of child abuse such as the deaths of children who were already known to professions within the multi-agency arena has raised the question of how those charged with the investigation of child abuse are actually trained.

Employers are responsible for ensuring that their staff are competent and confident in carrying out their responsibilities for safeguarding and promoting children's and young people's welfare. Additionally they should equip their staff with the necessary skills to Investigate Child Abuse and understand Child Protection procedures.

Refresher training should also be provided at regular intervals to ensure the continued professional development of staff.
