Road Report

Egenes contacted Rob Graber about creating a Moe Township website. It would take him a few hours to set it up and the annual fees would be around \$100 to \$125 to maintain it. He would like us to sketch out how we would like it arranged and what headings and pages we would like to see.

We would list items such as agendas, minutes, annual meeting items, policies, board members and contact info, dust control policy.
