We are pleased to present your Wastewater Annual Report. The Clean Water Act of 1999, passed by the North Carolina Assembly, requires Utilities to provide an annual report to their wastewater customers. This report summarizes the performances of your wastewater treatment plant and collection system over a 12-month period (January 1, 2020-December 31, 2020).

Description of Collection System and Treatment Process

Wastewater Treatment System: 133,430 GPD surface irrigation treatment disposal facility consisting of an influent bar screen, a grit removal chamber, a parshall flume and flow meter, a 3.5 acre primary facultative lagoon, a 115 GPM pump station with dual pumps, approximately 11,760 linear feet of six-inch force main, a 5.69-acre stabilization/storage lagoon, chlorination facilities, dual 1,000 GPM irrigation pumps, approximately 42.52 acres of wetted spray irrigation disposal/treatment area and an additional 29.73 acres have been added with the divisions approval. 12,876,426-gallon storage lagoon, a transfer pump station with two 550 GPM transfer pumps, an intermediate pump station with two 400 GPM transfer pumps, approximately 42.70 acres of spray irrigation area, and all associated piping, valves, controls, and appurtenances.

January 2020-Monthly Average Flow was 56,337 Gallons February 2020-Monthly Average Flow was 156,935 Gallons March 2020-Monthly Average Flow was 58,528 Gallons April 2020-Monthly Average Flow was 47,943 Gallons May 2020-Monthly Average Flow was 82,364 Gallons June 2020-Monthly Average Flow was 90,905 Gallons July 2020-Monthly Average Flow was 37,679 Gallons August 2020-Monthly Average Flow was 66,062 Gallons September 2020-Monthly Average Flow was 102,144 Gallons October 2020-Monthly Average Flow was 159,659 Gallons November 2020-Monthly Average Flow was 342,684 Gallons December 2020-Monthly Average Flow was 103,218 Gallons

The Town of Bailey exceeded the average monthly flow during each month except for July 2020.

II. Performance

Wastewater Treatment Plant

During the calendar year of 2020, the flow meter was calibrated, and various equipment upgrades were completed. We are happy to report the WWTP did not receive any Notice of Violations for the 2020 reporting year. In 2020, the average daily flow that was treated at this facility was 108,705.
