The County Board of Supervisors have placed Resolution 1776 on the agenda for their 12/21/2020 meeting to discuss its merits. We are asking as many people as can show up to the meeting at 700 n. Beale St. in Kingman at the County Offices as a public sign of support for adoption of the resolution. I have enclosed information and sample letters and we are asking everyone to email to both the City Council and the County Board of Supervisors to urge them to adopt Resolution 1776 as a means of restoring public trust in their City and County Governments. I am enclosing sample letters and contact information for these two groups so you can email them. We are also asking folks in Lake Havasu to show up for a rally as a show of public support for the adoption of Resolution 1776.
