
#### January Meeting

When: January 11, 2017 (Wednesday)

Where: DSU, Udvar Hazy Building, Room 121, 7 PM

Why: Dave Manley discusses his book <u>Ancient Galleries of Cedar Mesa</u>.

Photographer Dave Manley focuses his creative eye on the ancient rock art of Cedar Mesa, as remote a place as you can find in southeastern Utah. The greater Cedar Mesa area has been home to indigenous people for thousands of years. The cultures that came and went over time left a legacy of beautiful and intriguing marks on the rocks. Dave's crisp images show the breadth of the rock art found here, from isolated and simplistic to elaborately carved and/or painted panels. The book includes an introduction by Benjamin A. Bellorado and a cultural timeline by Bill Lipe.

#### Field Trip Plans for 2017

2016 is about over and it is time to start getting ready for next year's field trips. I think 2017 field trips are going to be enjoyable for all. There will be trips to local favorites and to some sites that will be new to most members. We will see a variety of rock art styles including Fremont and Barrier Canyon.

We begin in January by visiting a site located private land adjacent to the Virgin River. There are dozens of petroglyphs there. Most are believed to be Anasazi. On my last visit there, I took so many photos that I exhausted my camera battery. The hike is an easy one with some minor scrambling if you want. It is weather friendly so not likely to be cancelled. Still, dress warm and wear good hiking gear. Bring a lunch and water.

In February, we will visit an area near Fredonia to view water glyphs and some pictographs. There are about 400 recorded water glyph sites. Nearly all are located along the Arizona strip. Water glyphs are an enigma that has fascinating to me. There has been much speculation on what they mean. I suggest you Google "water glyphs" to get some background before we visit this site.

In March, we again head east to visit rock art on some private lands and will stop by the Fredonia Museum. Mr. Spendlove, the founder of the museum, is very knowledgeable about the areas cultural resources and has offered to give a personal presentation at the museum.

Other trips on the drawing board include an excursion to Lincoln County Nevada to view quite a few sites. There is mostly archaic style rock art here. This area is home to Pahranagat Man. Again, more Googling will tell all about him.

Another Nevada possibility is a joint trip with the a rock art group based in Las Vegas, You may recall the fine lecture given by Dr. Rafferty last spring dealing with the cultural resources located in the Valley of Fire. At that time he and I discussed such an adventure. Nothing firm yet, but if it does happen, our group will likely see some great Nevada sites. The Escalante area, Coral Sands Park near Colorado City, and scattered sites northeast of St. George may offer several other fine destinations.

Finally, I would like to suggest the membership consider one overnighter this fall. I have been poking around the Torrey, Utah area for the last several years and have located a number excellent Fremont sites that are fairly accessible. If you have thoughts about this type of an outing, please contact me at the email address below.

Again remember that you must attend the regular DAS lecture meeting that precedes the planned field trip in order to be eligible to go on that month's field trip. We do this to make sure that we have a complete list of possible attendees and to give the information on what to bring, where to meet, etc.

Some of you have approached me in the past and have wondered how you might become more involved with the field trip program. Well, the truth is, I need some help. There are several tasks that are required in order to put together each field trip...
