Oklahoma Islamic Academy's **Before & After School Care** is a before/after care program for PREK3 through 12th grade students. Parents can enroll their child for the morning session, afternoon session, or both sessions. The before & after school care program operates on the same schedule as the OIA school year calendar. A monthly payment chart is shown above. Cash and check payments can be made at OIA and payment is due once a month at the beginning of the month with regular tuition. Students will be charged the entire month for the current month of enrollment. No refunds please. School days closed due to weather will not be refunded. OIA typically does its best to remain open and only closes if Edmond Public Schools in the event of a weather emergency. We have factored scheduled days off and potential weather emergencies into the pricing in order to keep the pricing fair. Tuition is calculated for the scheduled days and times for which your child is enrolled. Refunds and/or reductions will not be made for illnesses, absences, and other activities. Payment may be made with check or cash. Nonpayment can result in the loss of your child's spot in the before/after care program or the summer daycare program. In the event school is closed due to a holiday, snow day, etc., you will not be refunded for that day. We have already factored scheduled days off and weather emergencies into the monthly prices. A late fee of \$1.00 per minute will be charged for any child remaining after the Before/After Care or Summer Daycare program closes for the day at 6:00 pm.

Tuition is calculated on a monthly basis and depends on the parent's choice of before care only, after care only, or both (before and after care). No refunds for the month of enrollment. If you decide to cancel enrollment in the before & after care program, please give us at least a one week notice, so we can remove your name from the roster for the upcoming month. If you do not cancel, we will assume that your child(ren) will continue enrollment in the next month and you will be charged for that month unless you provide written notice of enrollment cancellation.
