Farmington Town News:

2020 will have 4 major Elections:

February 18 - spring primary

April 7 - spring election & presidential preference primary

August 11 - partisan primary November 3 - general election

Elections times are 7am to 8pm at our Town Hall, E913 Prairie View Ln.

You can go to www.MyVote.wi.gov. to fill out and submit an absentee ballot request or even a new registration form.

Absentee voting will take place at the Town Hall, M-F 8am to 1pm beginning two weeks prior to election day, ending Friday before.

Summer road work: We seal coated nine roads, crack filled eighteen, filled many, many potholes and corrected several road sections regarding ditching for drainage problems.

Fall road tour: Took place in September, concentrating on shoulder and ditch areas of concern. If water does not leave the road bed properly, the road itself can be damaged.

We will tour again in the spring to analyze how the roads held up over the winter months.

Snow removal continues with Faulks Bros. Keep in mind our 3-zone plowing areas. Contact either Town Cell (715-513-0013), Caroline Murphy (715-498-9820), Craig Nelson (715-281-9051) or Mark Jensen (715-281-6085) with any concerns. The Town Board approved Ordinance 05-20-19(2019) Establishing the Banning of Snow and Water Placements on Roads (posted on town website www.farmington-waupaca.com). Please do not snow blow or shovel snow onto the roads. Once it becomes ice and solid, it makes it harder for the plows to clear. Thank you.

Snowmobile News: Scandinavia Vikings Snowmobile Club (Tim Dwyer 920-858-8583) and the County Line Trail Blazers Snowmobile Club (Craig Nelson 715-281-9051) were approved to run trails in the Town road right-of-ways. Understanding VA Death Benefits

VA DEATH BENEFITS

Like most things in life, dealing with the death of a loved one is best handled by the prepared. It's a topic no one wants to talk about, but everyone will have to work through at some point. Being prepared and arming your loved ones with your final wishes, rather than leaving them to sort it out in the wake of your passing, is the responsible handoff of a life well lived. In order to receive benefits applicants must meet eligibility requirements, provide necessary evidence, and make application. Benefits include Burial Flags, Burial Reimbursement (partial), Survivor Pension, Dependency and Indemnity Compensation, Presidential Memorial Certificate, Grave Marker, Accrued Benefits, Funeral Honors (State / VSO), War Period Flag Holder (CVSO), and other survivor benefits. Since every situation is unique, our office can assist in linking you with the appropriate benefits.

Note: To determine your eligibility, check eBenefits, contact VA Eligibility Center at 1-888-768-2132, or contact our office at 715-258-6475.

WHOS ELLIGIBLE? - Here are two common benefits, other benefits are available

Burial Benefits

- ·You paid for a Veteran's burial or funeral, AND
- •You have not been reimbursed by another government agency or some other source, such as the deceased Veteran's employer, AND
- •The Veteran was discharged under conditions other than dishonorable, AND
- •The Veteran died because of a service-related disability, OR
- •The Veteran was receiving VA pension or compensation at the time of death, OR
- •The Veteran was entitled to receive VA pension or compensation, but decided not to reduce his/her military retirement or disability pay, OR
- •The Veteran died while hospitalized by VA, or while receiving care under VA contract at a non-VA facility, OR
- •The Veteran died while traveling under proper authorization and at VA expense to or from a specified place for the purpose of examination, treatment, or care, OR
- •The Veteran had an original or reopened claim pending at the time of death and has been found entitled to compensation or pension from a date prior to the date or death, OR
- •The Veteran died on or after October 9, 1996, while a patient at a VA-approved state nursing home.

Survivor Pension

The deceased Veteran must have met the following service requirements:

- •For service on or before September 7, 1980, the Veteran must have served at least 90 days of active military service, with at least one day during a war time period.
- •If he or she entered active duty after September 7, 1980, generally he or she must have served at least 24 months or the full period for which called or ordered to active duty with at least one day during a war time period.
- •Was discharged from service under other than dishonorable conditions.

Survivors Pension is also based on your yearly family income, which must be less than the amount set by Congress to qualify.

While an un-remarried spouse is eligible at any age, a child of a deceased wartime Veteran must be:

- •Under 18, OR
- •Under age 23 if attending a VA-approved school, OR
- •Permanently incapable of self-support due to a disability before age 18

Your yearly family income must be less than the amount set by Congress to qualify for the Survivors Pension benefit. Learn more about income and net worth limitation, and see an example of how VA calculates the Survivors Pension benefit.

Town Electronic drop-off will be held April 22nd (EARTH DAY) at the town garage from 8am to 12 noon It is FREE. However, last year it did cost the township approx. \$3,845.29 which we considered well worth it. NO CONSOLE TV'S

Seasonal Weight Limits.....Will be placed on their Class B roads at the same time that the Waupaca County Highway Commissioner establishes theirs. Seasonal weight limits are necessary to protect roads because during the thaw period, road beds are weak due to excess moisture. A weaker road bed means the pavement is more easily damaged. Limits pertain to vehicles that are six tons per single axle and ten tons per tandem axle.

Permits, \$25.00 for single day use and \$35.00 for multiple day use will be provide by the town clerk upon request and fee payment at the town hall. There are exceptions whereby permits are NOT required: 1) implements of husbandry (farmers) 2) any business that has an entrance on town roads 3) a public utility, telecommunications provider, or a cooperative association providing heat, light, power or water if responding to a service interruption and 4) equipment operated for logging purposes during the day AND operated unladen for less than a half mile.

Understanding Zoning.....

The Town of Farmington has worked cooperatively with the Waupaca County Planning & Zoning Department since 2007 under their Comprehensive Plan as defined in Sec 66.1001(1)(a) and 66.1001(2) of the Wis Stats. On August 7, 2007, the Town Board adopted the Town of Farmington Year 2030 Comprehensive Plan which meets requirements of Wisconsin's Comprehensive Planning law to guide the Town Board in community decision making.

You may wonder why I am talking about this now. The town is "defined by the people who live and work there, the houses and businesses, the parks and natural features, its past, its present and its future. No matter the location, change is the one certainty that visits all places. No community is immune to its effects. How a community changes, how that change is perceived, and how change is managed are the subjects of community comprehensive planning.

The Town has received resident requests for changes to the Comprehensive Plan preferred land use designations, for changes to amend zoning map designations and for requests for conditional use permits for their property. We process these requests through our Town Plan Commission, made up of two board members, five residents and town clerk as secretary, who then forward their recommendation to the Town Board for their approval. If approved, these requests then travel to the County for final approval. The Town must make their zoning, land division, shoreland and floodplain zoning, and official mapping decisions in a manner that is consistent with the community's comprehensive plan. Paramount in the plan is the careful placement of residential development with regard to community's agricultural, natural and cultural resources. The town's plan preserves development rights throughout the township, with the goal of achieving desirable future by directing the most intensive development to areas that are suitable for such development. The best agricultural lands, natural resource rich areas, and areas that support outdoor recreation opportunities will be preserved as such for future generations, but will still allow development at lower densities.

The Waupaca Cty Planning & Zoning Office at the courthouse, serves as the facilitator for applications for amendments, conditional use permits, and land use permits. If you are considering a project on your property that involves the placement, construction, reconstruction, structural alteration or addition to a building or structure or the change in the use of a property, you will need to be in contact with the Planning & Zoning Office well in advance of your project. A land use permit is required for all projects involving structures including sheds, carports, decks, patios, etc, as well as placing impervious surfaces in shoreland areas. Proposals involving the use of the property may be more involved and can take time to obtain the necessary approvals. If projects are started prior to obtaining approval, the permit fees are doubled and the possibility exists that any structures placed or constructed without permits may need to be moved or removed from the property at the property owner's expense.
