Replace Single Axle Truck

The board found a 2001 Sterling L7500 with a reversible front steel plow – which we want, it has a wing, a fixed underbody scraper, and a sander. It has a caterpillar 250Hp engine with a 6 speed Allison transmission and a 39,000 GVW rating. It has a Henderson 10.5 foot box and a Henderson sander. It has 63,500 miles and 5613 hours. The price is \$29,500 delivered to us with a 30 day warranty.

We will look to sell our old single axle truck by sealed bids.
