## Minutes of the THMGC General Membership meeting held on Wednesday 20<sup>th</sup> February 2019.

**The Scrip report** was presented by R Frederick who advised the Outstanding Scrip total was \$8898.00. He called upon the Membership to approve a motion to retire the unclaimed 2016 Scrip at 12/31/19.The motion was seconded by L Lanni and passed by the Membership.

**The Tournament Chairman** B Dubay advised that on March 10<sup>th</sup> golf would be starting at 8am instead of the current 9am. He also advised Members the upcoming tournament would be the Devil Ball and will be played on March 20<sup>th</sup>. This will be a team event.

**The Membership Chairman** J Hamby advised the Membership currently stands at 276 total members of which 134 are Associate members. He also advised that should any Associate members wish to join the club as players they need to pay their Men's Club membership dues.

**The Handicap Chairman** J Kupka advised members not to post their rounds after the tournament today as he would attend to the matter as this was one of our four major tournaments.

**The Rules Chairman** L Wortman advised that due to the condition of the course he declared a lift, clean and place ruling throughout the course, one club length.
