He went to title a new vehicle and was told that he is in Duquesne. If he is in the City, he would like to enjoy the benefits that city residents enjoy. City Attorney Mike Talley stated that we need to find documentation that shows that he is in Duquesne.

### Update on City Matters

CDBG Housing Grant: The city received two bids for Grant Administrator. The bids were from Harry S. Truman and BLB & Associates. The Board will be reviewing the two applicants during a special meeting on September 16, 2015.

There is a street in Duquesne called Johnson Court it is a private drive and the owner would like for the Street grant fix his street. CDBG will not fix this street because it is a private drive, it is the owners responsibility to fix his private drive.

### Update on School Crosswalk

The crosswalk has been painted and signs ordered. The city is looking into the possibility of a soft trail to go from the roundabout to the school on 20<sup>th</sup> St. Chief Kitch is to go speak with property owners about allowing easements for this trail.

Public Comments Frank Herron 3853 E. 20<sup>th</sup> Mr. Herron wanted to know where the sidewalks on 20<sup>th</sup> St. may go, from where to where. The answer is that a soft trail is being discussed to by placed from the roundabout to the school. #### Joplin Humane Society

Duquesne does not have an animal control person, so we need some place to take stray animals. The question is will residents get charged if the city does not sign the contract. Vehicle 813 has been striped per Mayor Daugherty.

Vehicle 814 needs new tires.

The Chief has requested that the Tahoe get a light bar now that it is striped.

Surveillance at City Hall:

Alderman Heilbrun stated that when the city hires a 3<sup>rd</sup> party attorney, they should only be used for the reason that they were retained for.

Position currently held by David Weaver:

Alderman Heilbrun proposes that we change the contract to include other duties. Mayor Daugherty stated the Mr. Weaver's contract has ended. If the city continues to keep Mr. Weaver, then we need to decide if he will be 1099 or W9.

A contract will be presented at the next board meeting.

Bill Summary:

Reports of Special Boards, Committees & City Officers:

David Weaver stated that there are issues with a contractor on the first CDBG Grant. The contractor did not finish the work on 2 of the homes. The first issue is that they did not finish the dirt work which has left water under the house and has caused a mold problem. The seconded issue is a house was completed 60 days late, which there was a charge of \$5500.00 that was to be paid by August 23 and the contractor has not paid. Mr. Weaver is asking the Board to approve the retaining of an attorney to work with the applicants and the CDBG get this resolved.

Motion made by Alderman Welch, seconded by Alderman Ellsworth to approve council on the position that CDBG will reimburse the City for fees. Ayes: Aldermen Ellsworth, Welch, Bone, Heilbrun. Nays: none. Motion carried.

Alderman Ellsworth stated that the P&Z recommends to scrap the first bill about paving of parking lots and to start over. They would like a bill that will grandfather in businesses that are already open, and anything new will need to be paved.

Motion made by Alderman Ellsworth, seconded by Alderman Welch to strike going into closed session. Ayes: Aldermen Ellsworth, Welch, Bone, Heilbrun. Nays: none. Motion carried.
