Every dancer will receive a t-shirt as part of their costume cost. Please select your child's t-shirt size based on the sizing chart on the back of the order form. Any additional t-shirts for family members or friends can be purchased at \$20.00 a shirt. Names of all students will be on the back of the shirts.

- Saturday March 6: Sixth Group and Pep Elite competition fees are due; \$100 per dancer for 2 group events
