Biography

He has held and passed through most seats in Blue House Masonry from the Tyler

While stationed in Germany in District Number Nine, Washington Jurisdiction, he held the position as the Administrative Assistant and then appointed as the District Secretary which he held for several years before departing Germany in 1995.

On October 12, 1992, he received what is considered the last fraternal degree in Masonry, that of Grand Inspector General, 33rd Degree within the United Supreme Council, A.A.S.R, Southern Jurisdiction. After his return to Germany, he along with several others were released from the Southern Jurisdiction to become members of the United Supreme Council, A.A.S.R., Northern Jurisdiction to establish and form the Council of Deliberation, Orient of Europe.

While living in the State of Alabama, on August 1, 2012, he was appointed as the Special District Deputy Grand Master, Liaison to Alabama and appointed as the Recording Secretary of the Most Worshipful Grand Lodge, Prince Hall Affiliation of Washington Jurisdiction Reclamation Committee.

On April 11, 2015 while attending the Grand Communication of the Most Worshipful Union Grand Lodge, Jurisdiction of Florida, Belize, Central America, Germany, Incorporated, Prince Hall Affiliate he was selected as the Chartered Worshipful Master of Anthony T. Stafford, Sr. Military Lodge #16 located in Kaiserslautern, Germany. His dedication and works in the principals and ideals of

Masonry during his term in the seat as Worshipful Master, he received the appointment of Assistant District Deputy Grand Master of the newly formed District #44 in Europe for the Florida Jurisdiction.

He now resides in Lexington, KY with his wife Sharhan Livingston-Bell where he is employed with AECOM working as a Contractor with the Blue Grass Chemical Agent Destruction Pilot-Plant project in Richmond, KY to destroy the chemical agent filled munitions that are stored in Igloos on the Blue Grass Army Depot.
