TERMS AND CONDITIONS

In consideration of the mutual promises set forth herein, Jeffrey Schildroth DJ and Client agree to the following terms and conditions:

1. Client hires Jeffrey Schildroth DJ services for event set forth above and agrees to pay Jeffrey Schildroth DJ the required deposit with the return of this agreement and the full balance of the DJ Fee, including any overtime requested by client, no later than the day of the event.
2. Client is responsible for providing adequate setup location with appropriate electrical outlets and a 6-foot banquet table for the DJ equipment and shall make all arrangements to secure the location for the event. Client shall maintain adequate liability insurance to cover the event and attendees at the event. Client shall obtain any and all permits, licenses and authorization as may be required for the event and shall pay any fees associated therewith.
3. If Jeffrey Schildroth DJ cancels this agreement or is unable to attend the event through no fault of the Client, the deposit paid by the Client herein will be promptly refunded. The liability of Jeffrey Schildroth DJ under this agreement shall not exceed the deposit and Jeffrey Schildroth DJ shall not be made liable for any other damages, whether actual, incidental or consequential.
4. If client cancels this agreement before the event, Jeffrey Schildroth DJ may retain the deposit as liquidation damages and shall have no further obligations to client.
5. Client agrees to indemnify, defend and hold harmless Jeffrey Schildroth DJ their owners, agents and employees from and against any claim made by any person or entity for damages, losses or expenses of any nature or kind arising out of, or relating to, the event or the services provided herein, except any such claim, as may be caused by the sole negligence of Jeffrey Schildroth DJ in providing DJ services specified in this Agreement.
6. In the event that Client fails to pay the full balance due to Jeffrey Schildroth DJ on the date of the event, Client agrees to pay a \$100 late fee plus 55 per month on the unpaid balance due and shall be liable for all costs and expenses including reasonable attorney fees incurred by Jeffrey Schildroth DJ in collecting the amount due.
7. Jeffrey Schildroth DJ will provide DJ services to Client consisting of appropriate disc jockey, sound equipment, music and any other additional items mutually agreed upon.
