**Chairperson's Corner:** Plans for our next Assembly, to be held virtually, are well underway. The theme is "*Moving Forward with Unity, Courage and Perseverance*". You will find the Agenda in this issue of News & Views and on the website. It will be three days Fri-Sat-Sun. Assembly will be more like a normal face-to-face Assembly, so along with the business, there will be 3-minute talks from DR's and three theme sharings. I will be sending a question for DR's to consider for their 3-minute talk shortly. I also have incorporated an optional meeting, that will be hosted by District 5. The agenda shows it Friday after the business. **My question for you, is would you prefer it Friday after business, or Saturday early evening?** Please let me know if you have a preference. I wasn't sure how folks would feel about coming back Saturday evening, but it could be changed, if that is your preference. There will also be a closing speaker Sunday morning. All members, whether in a service position or not, are welcome to attend the Virtual Assembly.

There are three **Recommendations** for consideration this year. The one from AWSCM is a housekeeping recommendation for News & Views. The other two were submitted by a member. They will be in the Secretary's submission and on the website on the Assembly/AWSCM page. DR's please review these with your GR's, and GR's, review with your groups for their input during our discussions. This year is **Election year**. We have positions where members are completing two terms and will need to be replaced. We will need to elect a Delegate, as Wally may only serve one term. Others who have completed one term may choose to allow their names to stand for another term. In my submission for the February News & Views, I outlined who is eligible to allow their names to stand for various positions. To try and keep things flowing along through Elections, I respectfully request that if you are intending to allow your name to stand for a position, please send me your resume in advance, once completed. I will still ask if members are interested in standing from the floor, and they will need to complete a resume at that time. Members allowing their names to stand will be asked to read them prior to the election of the position they are standing for. We will be using Zoom polls for the elections. Having resumes in advance allow me to have the questions already entered into Zoom polls before Assembly, and amend them prior to electing each position. That will save some time. I have already received 3 resumes, and heard more are on the way, so thank you to those who have already sent them.

The **April Virtual Workshop** will be a presentation from Stepping Stones, the home of Lois & Bill W, co-founders of AA and Al-Anon. It will be followed by a Literature presentation by Doreen, our Literature Coordinator and Depot Manager. Check the Workshop page on the website for more info and the Zoom link.

## Secretary's Report:

Good afternoon my dear Al-Anon friends, Hope you all enjoying this beautiful weather, bring on Spring. There are 3 recommendations this year to vote on at Assembly.

 Recommendation for 2021 Assembly: Mickie went through all the motions. There is a motion from 1992, which states that News and Views could have a cash advance of \$250.00 that would be a starting fund for Districts taking on N&V's when the News & Views was printed and mailed out. There is a motion in 1994 that says that the Assembly Officers and Coordinators excluding Delegate have a maximum of \$100.00 yearly in operating expenses, effective Jan 1 1995: to be reviewed annually. Mickie recommends that the motion of 1992 concerning the cash advance of \$250.00 of N&V's be rescinded, while the motion of 1994 still stands. Recommendation accepted by AWSC members.

**Recommendation:** That the Motion of 1992 concerning the cash advance to News & Views of \$250 be rescinded. The News & Views Coordinator still receives \$100 annually for operating expenses, if required, per the 1994 Motion.

**Intent:** The News & Views no longer needs starting funds where the issues are sent out by email, and no longer printed and mailed to members

2. **Recommendation**: That Area 91 pay for the cost of hosting assembly up to a maximum of \$1000. Effective immediately.

**Intent**: The past treasurer asked for clarification on who pays for the costs for holding assembly at AWSCM 2018. The question was never been answered. In the past, assembly would not incur any expenses for hosting an assembly. Any expenses to host assembly were to be paid by the host district. In the past decade assembly has paid, in some years, the costs for hosting assembly without discussing the matter with the GRs. At Assembly 2019 a motion was passed to increase registration to \$25. It was implied this increase would be to assist in costs for assembly. Implying does mean it is a motion. Thus, we do not have an answer to the treasurer's original question.

## **Delegates Report:**

We have come a long way since I was writing this report for April 2020. So much has taken place within the AI-Anon organization in order to maintain some sort of normality and to remain a presence so the new member can find us. Well done, thank you. I know there are districts that are struggling due to very low numbers and meeting by Fongo or Zoom may not be convenient from one's home. We can only hope that in the coming months we may be able to meet in person following the meeting criteria set out by our respective authorities.

The World Service Conference that was to be held in New York this year was cancelled in December/January due to travel restrictions and the Covid numbers in that region of the USA. We will be doing a virtual Conference again this year, but as we have had time to plan, it will be different than last year where Conference was put together in three weeks. This year Conference starts Sunday afternoon, April 11 and runs until Friday night, April 16<sup>th</sup>. In order to accommodate all the time zones in North and Central America, our meetings will run from 12 noon until 9pm every day. The plan is to complete a full conference plus pick up what was not done last year during Conference week. As always, Conference week will be very busy and so will the weeks leading up and the weeks following. As I have sat on a number of committees, I have had a busy February and March, I think I'm ready.

The Chair of the Board Letter came out in February, they are available on the WSO web site and I would advise you to go have a look at them. They are from the Chair, Treasurer, Leadership Team, and Policy all very interesting and informative. As one reads through these and you recall what you have read in the last conference summary, also available on the WSO web site, you will note the progression of many of the topics and issues since last conference.

May be the most important item is the Chairs Letter were the names of the members put forward to Conference for affirmation for Regional and Trustee at Large, and our Tony Sampson is on that list for the candidate for Canada East Regional Trustee. Congratulations Tony, I know you will represent our Region (Canada East) very well and we wish you all the best over the next three years.

I would be amiss if I did not share a quote from the WSO Treasurers letter of appreciation to the membership:

As we reflect on this past year, it feels as if it has been a roller coaster ride! What a ride! We have a fabulous membership that continues to step up to keep our program moving forward! Over \$3M in contributions! We can only say, WOW! Thank you and please carry the message of gratitude back to your home group, your District, AIS, and Area. Without your contributions, the continued sales of literature, and WSO's ability to reduce expenses, we would not be where we are today.

And lastly, our Assembly this year is an important one and it will take participation from the entire membership and soul searching, our Higher Powers guidance, discussions with our sponsor and a gentle prod from those already in positions as elections for all positions at Assembly will be done in June. Service work was a huge part of my recovery. It enabled me to read and study our literature, yes, including our service manual. Do not ever be afraid to put your name forward for a service position. There are those who have been in those positions to help you along when you need guidance. You are never alone. There are a number of positions that have to be filled with new members, the Delegate being one, Secretary, Technology, Archivist, and Newsletter Editor, as these members have to rotate out. Members may choose to let their name stand for a second term, but these still have to be voted in, so, if there is a position you are thinking of, all positions are open except the Literature Depot, and that position stays with the incumbent until she/he wishes to give it up.

Talk it up with your District Representative, and let your Higher Power be your guide.
