## GROUND RULES AND INFORMATION

### ***Welcome, to the 34<sup>th</sup> Annual State Championship Horse Show***

Golf cart and "gator/mule" permits will be distributed by AOHA at a cost of \$10.00 and may be obtained at the window of Crawford Arena. At all times, drivers of these vehicles must be 16 years or older and driver must operate the vehicle in a safe manner subject to a \$100 fine and permit being revoked.

If called for drug testing, exhibitor and horse have five minutes from notification to report directly from the arena to the veterinarian.

**Anyone caught with horses in the camping areas, any day or night prior to or during the show, at any time of day or night & for any length of time, will be removed from the grounds and disqualified from showing for that year! No exceptions and NO refunds. Unload your horses from your trailer before you enter the camping areas.**

No horses allowed on the show grounds before 8 a.m Wednesday without the permission of AOHA Chairman, Jimmy Avery.

No scooters (gas, electrical or manual), four wheelers, mopeds, bicycles or motorcycles allowed on the show grounds at any time or day.

If you miss your cut in judged events or turn to ride in timed events, (without permission of AOHA) you will be disqualified from that class. *The number of cuts in a class or number of riders in an event may change during the day.* It is important to inform AOHA if you choose to scratch from you class. Please assist us and other exhibitors by filling these forms out prior to your class

Please make sure all back and saddle numbers are stored in a secure location. Replacement is not guaranteed. Make sure the correct number is worn for the correct horse/exhibitor combination. Do not alter, deface, cut or decorate the number under penalty of disqualification. It is recommended you laminate your number to protect it from weather and wear. Lamination of numbers will be available at the Crawford office for a small fee.

A veterinarian will be on the grounds or on call at all times. If a vet is needed during the show hours, contact any AOHA official at Crawford arena. Before or after show hours call 334-727-8436 or 727-8461, In case of sickness/injury to an individual, contact any AOHA official.

NO DOGS & NO Alcoholic beverages allowed under Crawford.

Park all golf carts in the **designated Parking area** before making entry into the vendor area at Crawford. Do not block access points into the VENDOR AREA at Crawford. Do not bring golf carts under the cover of Crawford. YOU will be required to move them if your blocking access points. **EXCEPTION UNLESS YOU ARE AN OFFICER, DIRECTOR, OR COMPUTER PERSON.**

Camper/living quarter trailer hookups are not the responsibility of AOHA

Cowboy church service will be held in Crawford on Sunday at 7a.m.

All PONIES must be measured at the show with the exception of those entered ONLY in costume leadline. ***Measurement will take place on September 2<sup>nd</sup> (THURSDAY) from 12:30-1:30p.m. and (FRIDAY) September 3<sup>th</sup>, 6:00-7:00 a.m. LOCATION will be Crawford Arena on concrete.***

All gaited ***horses must present themselves to the DQP before each class in which they are entered.*** DQP will be located at Crawford Arena.

No "unqualified" horses (barn buddies, just for sale, etc) allowed on show grounds. All horses present must be qualified to show in at least one class.

Opening ceremonies will be held at **Crawford Arena on September 2<sup>nd</sup> at 9:00a.m.** There will be a parade of association flags, Hall of Flame induction and welcoming remarks by AOHA and State of Alabama Officials.

\*\*\*Auction for the AOHA book pages (front, back, center, etc) will be held Saturday after class J37-English Pleasure 18 & over, during lunch break at Crawford Arena. Half due at time of Auction, balance due in 30 days non refundable.

## **RV PARKING AND GROUNDS**

### **RULES AND REGULATIONS**

A DUMPING STATION IS LOCATED IN THE OPEN FIELD RIGHT BESIDE CRAWFORD CAMPGROUND. ANYONE FOUND TO BE UNLAWFULLY DUMPING WASTE ANYWHERE OTHER THAN THE ON SITE DUMPING STATION WILL BE ASKED TO LEAVE THE PREMISES **IMMEDIATELY!**

1. R.V. HOOK-UP CAMPING SPACES ARE RENTED BY RESERVATION ONLY @ 334-356-6866.
2. PERSONAL ITEMS SUCH AS CONES, TAPE, SIGNS OR ANY OTHER TYPE OF BARRICADE WILL NOT BE ALLOWED TO HOLD A SPACE FOR OTHER CAMPERS. COLISEUM STAFF WILL REMOVE THESE ITEMS SO THAT CAMPERS WHO HAVE PAID FOR THE SPACE MAY HAVE USE OF THE SPACE. ONE SPACE IS NO LARGER THAN 24' X 50'. IF MORE SPACE IS NEEDED THERE WILL BE AN EXTRA CHARGE.
3. CAMPERS WILL MAINTAIN CLEAN GROUNDS BY PLACING ALL LITTER IN THE TRASH RECEPTICLES.
4. DO NOT PARK VEHICLES IN THE SPACES RESERVED FOR COLISEUM AND CONCESSION PERSONNEL.
5. FOR THE SAFETY OF ALL GARRETT COLISEUM PATRONS, ALL CAMPING THAT REQUIRES ELECTRICAL OR WATER HOOK-UP MUST BE STATIONED INSIDE THE CAMPGROUND ON THE FACILITY PREMISES. ONLY PRIMITIVE CAMPING WILL BE ALLOWED OUTSIDE OF THE TWO RV CAMPGROUND AREAS.
6. ABSOLUTELY NO HORSES OR LIVESTOCK ALLOWED IN THE CAMPGROUND AREAS AT ANY TIME. IF YOU ARE CAUGHT DOING THIS, YOU WILL BE ASKED TO LEAVE THE PREMISES.
7. YOU CAN **NOT** BRING ANY KIND OF SHAVINGS OR HAY INTO THE CAMPGROUND TO PUT BY YOUR TRAILER OR CAMPER. IF YOU USE THE DESIGNATED TIE-OUT AREA YOU SHOULD NOT HAVE TO DO THIS. IF CAUGHT DOING THIS, YOU WILL BE ASKED TO LEAVE THE PREMISES.
8. THE **FIRE LANES MUST BE KEPT OPEN AT ALL TIMES** AROUND ALL THE BUILDINGS ON THE GROUNDS FOR USE IN EMERGENCY SITUATIONS.
9. **NO 4-WHEELERS ALLOWED ON THE PROPERTY.** GOLF CARTS & UTILITY VEHICLES ONLY. YOU MUST BE A LICENSED DRIVER TO OPERATE A VEHICLE ON THE COLISEUM GROUNDS.

10. ALL APPROVED VEHICLES MUST HAVE A PERMIT FROM AOHA.
11. ANY TAMPERING W/GARRETT COLISEUM PROPERTY, INCLUDING BUT NOT LIMITED TO ELECTRICAL PANELS/BOXES, WATER SUPPLY AND ANY OTHER REAL PROPERTY WILL RESULT IN IMMEDIATE EXPULSION FROM THE GROUNDS & THE EVENT. IF YOU HAVE A PROBLEM, A COLISEUM REPRESENTATIVE WILL BE THERE TO ASSIST WITH THE ISSUE IN A TIMELY MANNER AFTER NOTIFICATION.
12. ADDITIONAL RULES AND REGULATIONS, NECESSARY FOR SAFETY AND THE SUCCESS OF THE EVENT, MAY BE ADDED AND ENFORCED. IF THIS SITUATION ARISES, THE LICENSOR AND THE LICENSEE WILL CONFER AND AGREE TO IMPLEMENTATION.

### **HORSE AND STALLS**

1. ABSOLUTELY NO HORSES OR LIVESTOCK ARE ALLOWED TO BE TIED OUTSIDE OF THE STALL AREAS. YOU MUST USE THE DESIGNATED TIE-OUT AREAS.
2. THERE IS NO GRILLING OR OPEN FLAME OF ANY TYPE ALLOWED IN THE BARN/STALL AREAS. GRILLING IS **ONLY** ALLOWED IN DESIGNATED CAMPING AREAS.
3. THERE IS A LIMITED SUPPLY OF OUTLETS AVAILABLE IN THE BARN; HOWEVER, CIRCUITS CAN BE CHALLENGED BY COMBINATIONS OF BLOWERS AND FANS. PLEASE USE DISCRETION IN THE NUMBER OF FANS YOU USE TO AVOID OVERLOADING THE CIRCUITS. NO REFRIGERATORS, OTHER APPLIANCES, OR TRAILERS OF ANY KIND MAY BE PLUGGED IN AT BARN. WHEN CIRCUITS ARE OVERLOADED, NO ONE HAS POWER.
4. IN ALL INSTANCES, GCRC AND AOHA REPRESENTATIVES WILL NOTIFY EACH OTHER IN ANY EVENT OF RULES VIOLATIONS.
