AGREEMENT

The Facility agrees to exercise due diligence and reasonable care, and to keep the premises sanitary and properly enclosed. All dogs are handled or cared for by Facility staff without liability on Facility's part for loss or damage from disease, theft, fire, death, escape, injury or harm to person's other dog(s) or property said dog(s) or from other unavoidable causes, due diligence and care having been exercised.

Should any daycare dog become ill or seem to be in need of medical consideration, the Facility reserves the right to administer aid and/or to use any available veterinarian. Any expenses so incurred shall be paid by the Parent/Guardian of said dog(s) in addition to other fees listed in this

Parent/Guardian agrees to pay the rate for day care in effect by the end of the week in which the pet resided in the Facility; Prices are subject to change at any time, without notice. No daycare dog will be released until all charges are paid in full by the end of the week.

Parent/Guardian shall remain liable for complete day care bill, as well as other charges incurred in the care and maintenance of said dog listed on this contract. It is expressly agreed by the Parent/Guardian and the Facility that the Facility liability shall in no event exceed the lesser of the current tangible value of a pet of the same species or the sum of \$200.00 per animal. The owner further agrees to be solely responsible for any and all acts or behaviors of said pet(s) while in the care of the Facility. The Parent/Guardian of the dog(s) agrees to pay reasonable attorney fees incurred by the Facility in the collection of any day care services, training, or other charges incurred by the Parent/Guardian of the dog(s).

The dog must be current on vaccinations appropriate for its age: to include but not limited to, DHLP-P, Rabies, and Bordetella (Kennel Cough). Valid proof of vaccinations must be presented before the dog can be dropped off for day care. Parent/Guardian also agrees to maintain medical health of said pet and to keep the Facility appraised of any updates. A negative stool test is required biannually.

The Facility reserves the right to refuse or remove any dog at any time. The Facility will not accept any dog over 7 months that is not sterilized.

The Facility requires dogs left in the care of the Facility to wear a flat buckle/quick release collar.

Parent/Guardian agrees that the dog will be picked up by Parent/Guardian or pre-approved agent no later than 5 minutes before closing unless an extension is agreed prior to drop off for daycare. Late charges will be executed, if necessary.

Parent/Guardian agrees that the above described dog may be videotaped, photographed, or recorded. The Facility shall be the exclusive owner to the results and all proceeds of such tapings, photographs, and recordings with the rights throughout the world, and unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner. The Parent/Guardian further agrees that the dog may be used in any and all media and in the promotion, advertising, sale, publicizing and exploitation of the Facility. - Parking is available in front of the building.

Documentation before any dog is allowed to attend daycare.

- 3 page Application and Signed waiver.
- Proof of health records or titer* DHPP, Rabies, Bordatella, negative stool check tested within last 3 months. * Last receipt should contain this information at the bottom.
- Negative stool checks required twice a year and vaccination records updated yearly.
- Payment is due by end of week.

Equipment:

- Dogs are to be on leash when entering and exiting the building.
- An inexpensive flat collar for play. Dogs will pull and chew on collars during play. We will not be responsible for replacing collars.
- If your dog is on a training collar this should be worn when entering and exiting. We will remove it before play.

During the day: 🥍

- Drop off and Pick up between 6:30am and 5:30pm.
- A fee will be charged if late without notification.
- You are responsible to pick up after your dog, inside and outside the building.
- We will feed or place your dog in rest time at your request.
- There may be times that we feel it necessary to place your dog in time out.
- That Place for Pets reserves the right to expel any dog that shows aggression towards people or other animals. Please disclose any aggressive tendencies prior to attending daycare.

Absenteeism: 降

- If your dog is ill please do not bring her to daycare.
- You are encouraged to call and let us know so we can monitor and inform fellow attendees.

What to expect when you get home:

- First day may be a little stressful for some. He may not want to eat or drink, or have possible lose stool. If this continues past 24 hour please contact your veterinarian and us.
- Otherwise you will find a tired possible smelly puppy from a day of play.
