## 1. BIDDING WARS – SOMETHING NEW FOR THE CITY

The city of Terre Haute will be involved in a new process for the collection of bids relating to the purchase of two dump trucks for the City of Terre Haute Street Department. Companies choosing to bid on the trucks have already submitted the bid information relating to specifications, and those companies meeting the requirements have been invited to submit bids in a process referred to as a "reverse auction" system.

On March 12, 2009, at 2:00 PM the reverse auction will be held online through the BidBridge company. Those submitting bids will be able to see the bids offered by their competitors and will have a chance to "outbid" their competitors. The public and the members of the Board of Works and Safety will be able to view the bidding as it occurs. When the time limit is met, the low bid will be accepted.

# 2. LEGISLATIVE ACTION NETWORK

The committees have met and the remaining bills that have passed out of committee will now be heard and debated on Monday and Tuesday by the full House and Senate. Those that pass the house of origin will be assigned to committee in the opposite legislative body and the process will begin again.

#### 3. TOWNSHIP GOVERNMENT

According to the Associated Press, the Indiana Senate passed a bill that would eliminate three-member township boards. The township boards' duties of adopting the annual township budget and acting as the township's fiscal and legislative body would be shifted to the county council. Township trustees (the executive branch) would remain. This is despite Gov. Daniels' proposal to eliminate township government completely.

The township table that was published in last week's *Tax Matters* is updated here to include all the board members of each township. Each township also includes its respective tax rate. The population of the federal penitentiary was subtracted from the Honey Creek township figure, so the expenditures per person listed now better reflects that township.
